A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, APPROVING AND AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO REJECT ALL BIDS RELATED TO RFP-4729-22-WV FOR THE ARTSPARK IMPROVEMENTS PROJECT, A GENERAL OBLIGATION BOND PROJECT, IN ACCORDANCE WITH SECTION 38.43(D) OF THE PROCUREMENT CODE.

WHEREAS, the Department of Design and Construction Management (“DCM”) and the Department of Parks, Recreation, and Cultural Arts (“PRCA”) desired to fabricate and install an architectural fence around the amphitheater to allow for ticketed events at ArtsPark at Young Circle; and

WHEREAS, on May 5, 2022, the City of Hollywood followed the formal solicitation procedures outlined in Section 38.43 of the Procurement Code to advertise Request for Proposals No. RFP-4729-22-WV for ArtsPark Improvements Project on [www.bidsync.com](http://www.bidsync.com); and

WHEREAS, the City received three bids in response to RFP-4729-22-WV by the bid due date of June 14, 2022; and

WHEREAS, DCM and PRCA evaluated the three bids received in accordance with the criteria established in the solicitation, and determined the responses to be non-responsive and non-responsible; and

WHEREAS, RFP-4729-22-WV allows for the cancellation or rejection of bids; and

WHEREAS, Section 38.43(D) of the Procurement Code states that when any goods, supplies, materials, equipment or services shall be purchased and the estimated annual amount exceeds \$100,000.00 the Chief Procurement Officer shall have the authority to recommend to the City Manager, for City Commission consideration, the rejection or cancellation of all bids or proposals, or parts of all bids or proposals, for any one or more goods, supplies, materials, equipment or services; and

WHEREAS, the Director of DCM and the Chief Procurement Officer recommend that the City Commission reject all bids related to RFP-4729-22-WV for the ArtsPark Improvements Project based upon the facts and circumstances set forth above.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA.

Section 1: That the foregoing "WHEREAS" clauses are ratified and confirmed as being true and correct and are incorporated in this Resolution.

Section 2: That it rejects all bids submitted for RFP-4729-22-WV for the ArtsPark Improvements Project due to the bids being non-responsive and non-responsible.

Section 3: That this Resolution shall be in full force and effect immediately upon its passage and adoption.
