A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO EXECUTE AN INTERLOCAL AGREEMENT WITH BROWARD COUNTY FOR OPTIONAL COUNTY SERVICES RELATED TO DISPOSAL OF BULK TRASH, YARD WASTE, HOUSEHOLD HAZARDOUS WASTE AND ELECTRONICS, AND OFFERS FREE PAINT GIVEAWAY TO HOLLYWOOD RESIDENTS FOR TWO YEARS IN ACCORDANCE WITH SECTION 38.41(C)(9) OF THE PROCUREMENT CODE. (BEST INTEREST)

WHEREAS, on August 28, 2019, the City Commission passed and adopted Resolution No. R-2019-237, which authorized an Interlocal Agreement ("ILA") with Broward County for Optional County Services that include Household Hazardous Waste and Bulk Trash and Yard Waste Drop-off programs for one year with four additional one-year renewal terms; and

WHEREAS, the ILA in effect is set to expire on September 30, 2024, and has no renewals; and

WHEREAS, the Department of Public Works desires to enter into a new Interlocal Agreement with Broward County for "Keep Broward Beautiful" Program, Household Hazardous Waste, Bulk Trash and Yard Waste Drop-off Programs for a two-year period, commencing October 1, 2024 and expiring September 30, 2026, with the option of three additional one-year terms; and

WHEREAS, Article 5 of the ILA provides that the City's payment for such services, which is based on a per capita calculation, shall be escalated by an amount based on the actual cost of services annually, and the annual escalation shall be determined by the County's Contract Administrator based on increases in direct and indirect costs incurred by the County to perform the Scope of Services; and

WHEREAS, the County's Household Hazardous Waste and Electronics Program provides disposal services and electronics recycling at permanent collection sites and at remote collection events, and offers the Recycled Paint Program to residents free of charge; and

WHEREAS, the per capita fee for Household Hazardous Waste under the proposed ILA and pursuant to Article 5 will be \$2.69, for an annual amount of \$411,750.00; and

WHEREAS, the per capita fee for Bulk Trash and Yard Waste Drop-off Program will be \$1.67, for an annual amount of \$255,622.00; and

WHEREAS, the per capita fee for the "Keep Broward Beautiful" Program will be \$0.41, for an annual amount of \$62,757.00; and

WHEREAS, the County's Residential Drop-off Program of Bulk Trash and Yard Waste disposal will be free of charge to residents at permanent collection sites; and

WHEREAS, Section 38.41(C)(9) of the Procurement Code states that when the City Commission declares by a five-sevenths affirmative vote that competitive bidding and competitive proposals are not in the best interest of the City, such purchases are exempt from competitive bidding and competitive proposal requirements; and

WHEREAS, a portion of the funding for the Interlocal Agreement will be available in the FY 2025 Operating Budget in account numbers 445.520101.53400.543600.000000.0000 and 445.520101.53400.543610.000000.0000, and will be budgeted in subsequent fiscal years' operating budgets subject to approval and adoption by the City Commission.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA.

<u>Section 1</u>: That the foregoing "WHEREAS" clauses are ratified and confirmed as being true and correct and are incorporated in this Resolution.

Section 2: That it approves and authorizes the execution, by the appropriate City officials, of the Interlocal Agreement with Broward County for Optional County Services, together with such non-material changes as may subsequently be agreed to by the City Manager and approved as to form by the City Attorney.
