Eleven (11) construction bids were received for the above-referenced project on December 23, 2020. Bids were received from the following construction contractors:

- 1. Southern Underground Industries, Inc.
- 2. Southeastern Engineering Contractors, Inc.
- 3. Florida Engineering and Development Corp.
- 4. JVA Engineering Contractor, Inc.
- 5. Lanzo Construction Co., Florida.
- 6. Ric-Man Construction Florida, Inc.
- 7. Magnum Construction Management, LLC d/b/a MCM.
- 8. Man-Con Incorporated.
- 9. Giannetti Contracting Corporation.
- 10. R.P. Utility & Excavation Corp.
- 11. Metro Equipment Service, Inc.

The bids were tabulated and are attached hereto as Exhibit A. The tabulated amount for the five (5) lowest bidders does not differ from their respective written bid amounts except for the tabulated amount of \$2,043,586.00 for Ric-Man Construction Florida, Inc. which differs by \$1,200 from the written amount of \$2,042,386.00. As a result of the bid tabulation, Southern Underground Industries, Inc. was identified as the apparent low bidder. The bids were ranked from lowest to highest and are included on the following page.

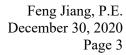
Section 00100 Instruction to Bidders of the Contract Documents required specific information of the bidders. The five (5) lowest bids were reviewed against the bid item checklist, provided as Exhibit B. Some of the requirements detailed in the Instructions to Bidders were incomplete and, while most bidders appear to have the required experience, some bidders failed to provide enough supporting documentation in their bids to confirm all qualifications are met. Additional requests for information were sent to the two lowest bidders to confirm they meet all the qualifications, and both responded with the requested supporting documentation.

Upon further review of Ric-Man Construction Florida, Inc. and Southeastern Engineering Contractors, Inc. bids, it was determined that they provided an incomplete bid as they failed to include the resume of the project superintendent and project manager. In addition, Ric-Man Construction Florida, Inc. did not use the most updated bid form provided in Addendum No. 6.

Project references contacted for the two (2) lowest bidders, Southern Underground Industries, Inc., and R.P. Utility & Excavation Corp., were positive. The consensus is that the similar projects performed by both contractors were completed to the satisfaction of the utility Owners. All the reference forms are attached as Exhibit C. Ric-Man Construction Florida, Inc and Southeastern Engineering Contractors, Inc. references were not contacted due to their bids being incomplete. Gianetti Contracting Corporation references were contacted but as of today they have not responded to our request.

Based on the information above, Southern Underground Industries, Inc. has adequately demonstrated their experience, overall positive references, and submitted the lowest bid. Southern Underground Industries, Inc. has agreed to lower their pay item for mobilization, bonds and insurance costs to comply with the maximum 3% requirement for the sum of bid items 4-22 as specified in section 01025 with the overage being included in the demobilization pay item. Tetra Tech recommends award of the construction contract to Southern Underground Industries in the amount of \$1,974,652.44.
