WHEREAS, the Information Technology Department and various Citywide departments are in need of telecommunication services; and

WHEREAS, the State of Florida Department of Management Services awarded Contract No. DMS-17/18-004D for SUNCOM Communication Services, which was procured by competitive bid and awarded to NWN Corporation on July 17, 2020, with a termination date of July 16, 2025; and

WHEREAS, Amendment No. 3 to Contract No. DMS-17/18-004D renewed the term effective through June 30, 2030; and

WHEREAS, on May 15, 2024, City Commission approved Resolution No. R-2024-156, authorizing the utilization of Contract No. DMS-17/18-004D; and

WHEREAS, the Information Technology Department has utilized Contract No. DMS-17/18-004D to install and support a new cloud-based phone system, dial plan, and contact center system with an ongoing monthly cost of approximately \$35,000.00; and

WHEREAS, the Information Technology Department is requesting a contingency of \$50,000.00 under Contract No. DMS-17/18-004D to be used on an as-needed basis; and

WHEREAS, the Director of the Information Technology Department recommends that the City Commission approve and authorize the continued utilization of Contract No. DMS-17/18-004D with the renewal term from the period October 1, 2025, through June 30, 2030, for an amount up to \$2,045,000.00; and

WHEREAS, a portion of the funding for the Purchase Order will be made available in the FY 2026 Operating Budget in account number 557.130101.51900.541021.000000.000, and will be budgeted in subsequent fiscal years' operating budgets subject to approval and adoption by the City Commission.
