A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO EXECUTE THE ATTACHED CONTRACT BETWEEN THERMA SEAL ROOF SYSTEMS, LLC AND THE CITY OF HOLLYWOOD FOR ROOF REPLACEMENT ON THE MLK JR GYMNASIUM BUILDING, IN THE AMOUNT OF \$89,450.00.

WHEREAS, the Department of Public Works has determined that the roof above the Martin Luther King Jr. Gymnasium Building needs to be replaced; and

WHEREAS, specifications and details to replace the roof were prepared by a City consultant and the Notice to Bidders was advertised online via BidSync on February 9, 2017; and

WHEREAS, these construction documents and specifications were viewed by forty-three (43) vendors on BidSync and ten (10) vendors downloaded the Project Manual and specifications; and

WHEREAS, through receipt of the City's bid specifications for this project, all contractors have been provided with a copy of the City's contract, including the terms and conditions contained therein; and

WHEREAS, six (6) bids were received and publicly opened at 10:00 AM on March 14, 2017, and the responsive bids are as follows:

WHEREAS, City staff reviewed the six (6) bids and determined that the bid submitted by Therma Seal Roof Systems, LLC was the overall lowest, responsive and responsible bid, and have recommended the award of the bid to Therma Seal Roof Systems, LLC in the amount not to exceed \$89,450.00; and

WHEREAS, on October 5, 2016 the City Commission adopted R-2016-291 which continued the appropriation for previously approved Capital Projects from FY2016 and FY2017 and including funding for the Public Works Re-Roofing Program; and

WHEREAS, funding is available in account numbers 34.5114.14452.519.006301 and account number 34.5116.16452.519.006301;

NOW THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:

Section 1: That it hereby approves and authorizes the execution, by the appropriate City Officials, of the attached contract between Therma Seal Roof Systems, LLC, and the City of Hollywood, together with such non-material changes as may be subsequently agreed to by the City Manager and approved as to form and legality by the City Attorney.

Section 2: That this resolution shall be in full force and effect immediately upon its passage and adoption.
