A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, APPROVING AND AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO EXECUTE AN AGREEMENT WITH CBIZ ADVISORS, LLC FOR TAX CONSULTING SERVICES REGARDING PAYROLL IMPLEMENTATION OF THE NEW RETIREMENT PLANS IN AN AMOUNT UP TO \$35,000.00.

WHEREAS, through collective bargaining, representatives of the City and AFSCME Local 2432 ("AFSCME") agreed to add to the current defined benefit ("DB") plan, two more retirement pension plan options, namely a defined contribution ("DC") plan, and a plan comprised of both a DB and a DC component or Hybrid plan ("Hybrid"); and

WHEREAS, the City determined the need for pension tax consulting services in the implementation of these new pension plans; and

WHEREAS, the City solicited quotes from three accounting consulting firms and determined CBIZ Advisors, LLC (CBIZ") the most favorable in terms of price and experience in quality of services rendered to the City on other engagements; and

WHEREAS, the City determined that it is in the City's best interest to enter into an agreement with CBIZ for this one-time project to support the Financial Services Department in confirming the proper set up and due diligence review in an amount up to \$35,000; and

WHEREAS, the agreement confers limitations on damages at no more than ten times the fees paid by the City to CBIZ for these specific agreed-upon services, giving rise to the claim; and

WHEREAS, funding for the agreement is available in account number 001.190104.51900.591011.000000.000.000.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:

Section 1: That the foregoing "WHEREAS" clauses are ratified and confirmed as being true and correct and are incorporated into this Resolution.

Section 2: That appropriate City staff is authorized to execute an agreement for this one-time project in an amount up to \$35,000.00 with CBIZ Advisors, LLC, including a limitation on damages at no more than ten times the fees paid by the City to CBIZ for these specific agreed upon services giving rise to any claim.
