**Proposed Legislation:**

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO APPLY FOR AND IF AWARDED ACCEPT FY2015 BULLETPROOF VEST PARTNERSHIP PROGRAM GRANT FUNDS FROM THE BUREAU OF JUSTICE ASSISTANCE IN THE APPROXIMATE AMOUNT OF \$48,945.04 AS PARTIAL REIMBURSEMENT FOR THE PURCHASE OF BULLETPROOF VESTS; AUTHORIZING THE CONTRIBUTION OF FEDERAL LAW ENFORCEMENT FORFEITURE FUNDS PURSUANT TO THE FEDERAL COMPREHENSIVE CRIME CONTROL ACT OF 1984 IN THE APPROXIMATE AMOUNT OF \$48,945.04 AS REQUIRED MATCHING FUNDS FOR THIS PURPOSE; AND FURTHER AUTHORIZING, UPON SAID GRANT AWARD, THE EXECUTION OF AN AWARD AGREEMENT BY THE APPROPRIATE CITY OFFICIALS IN ORDER TO ACCEPT SAID GRANT FUNDS, AT NO COST TO THE CITY; AUTHORIZING THE DEPARTMENT OF FINANCIAL SERVICES TO ESTABLISH ACCOUNT(S) AS MAY BE NEEDED; AND FURTHER AUTHORIZING THE RECOGNITION OF REVENUE AND APPROPRIATION OF NET ASSETS IN FUND 12 TO THOSE ACCOUNTS.

**Explanation:**

This Resolution seeks authorization for the appropriate City Officials to prepare and submit a request for funding, and execute an agreement if awarded, for FY 2015 Bulletproof Vest Partnership Program Grant funding from the Bureau of Justice

Assistance in the amount of \$48,945.04. Authorization is also sought to appropriate \$48,945.04 in funding from Federal Law Enforcement Forfeiture Funds (LEFF) pursuant to the Federal Comprehensive Crime Control Act of 1984 to use as the required matching funds.

This expenditure of Law Enforcement Forfeiture Funds serves a legitimate Law Enforcement purpose as prescribed by the Department of Justice's Equitable Sharing Guidelines for the expenditure of Federal Law Enforcement Forfeiture Funds. The Guidelines require that the Police Department obtain approval for such expenditures from the City Commission.

Further, this resolution seeks to authorize the Department of Financial Services to recognize revenue and appropriate \$48,945.04 in Net Assets from the Law Enforcement Forfeiture Fund (Fund 12) into an expenditure line item account(s) number, yet to be created by the Department of Financial Services, to provide funding as requested.

Because Law Enforcement Forfeiture Funds will be used for this purchase, the taxpayers of the City of Hollywood will incur no cost for this expenditure.
