A RESOLUTION OF THE CITY COMMISSION OF THE CITY **APPROVING** OF HOLLYWOOD, FLORIDA, AND AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO EXECUTE A BLANKET PURCHASE AGREEMENT WITH **PANTROPIC POWER** INC. FOR **GENERATOR** PREVENTATIVE MAINTENANCE AND REPAIR SERVICES IN AN ANNUAL AMOUNT UP TO \$500,000.00 FROM DECEMBER 1, 2023 THROUGH AUGUST 20, 2024, BASED CONTRACT UPON BROWARD COUNTY NO. OPN2125761Q1 ACCORDANCE WITH **SECTION** IN 38.41(C)(5) OF THE **PROCUREMENT** CODE. (PIGGYBACK)

WHEREAS, the Department of Public Utilities requires specialized maintenance and repairs services for the emergency power equipment at the Southern Regional Wastewater Treatment Plant, Water Treatment Plant, Sewer Lift Stations, Stormwater Stations, Biscayne Wells, and portable electrical generators; and

WHEREAS, the desired Generator Preventative Maintenance Services were competitively bid by Broward County on August 21, 2023, which was awarded to Pantropic Power, Inc. ("Pantropic") under Broward County Contract No. OPN2125761Q1 ("Contract"); and

WHEREAS, the current term of the Contract is from December 1, 2023 through August 20, 2024, with an option to renew the contract for two additional one-year renewal periods; and

WHEREAS, Pantropic has agreed to extend to the City the same pricing under the terms and conditions set forth in the Contract; and

WHEREAS, the period of performance during which the desired Generator Preventative Maintenance Services will be acquired is over a one-year period from December 1, 2023 through August 20, 2024 for an annual amount up to \$500,000.00; and

WHEREAS, Section 38.41(C)(5) of the Procurement Code allows the Chief Procurement Officer to procure, without formal solicitation procedures, all goods, supplies, materials, equipment, and services that are the subject of contracts with the state, its political subdivisions, the United States government, other governmental entities, or a corporation not for profit whose members are governmental entities, public officers, or any combination thereof ("piggyback"), provided that the goods, supplies, materials, equipment, or services are the subject of a price schedule negotiated by the entities listed above and is based strictly on competitive bids, quotations, or competitive proposals and not on any preference

and such utilization of other governmental entities contracts shall be permitted only during the term of the other governmental entity's contract; and

WHEREAS, the Director of the Department of Public Utilities and Chief Procurement Officer recommend that the City Commission approve and authorize the execution of a Blanket Purchase Agreement with Pantropic for Generator Preventative Maintenance Services over a one-year period from December 1, 2023 through August 20, 2024 in an annual amount up to \$500,000.00; and

WHEREAS, funding for the Blanket Purchase Agreement is available in account numbers 442.400602.53600.546310.000000.000, 442.400502.53600.552240.000000.000, and 443.410101.53800.546310.000000.000.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA.

<u>Section 1</u>: That the foregoing "WHEREAS" clauses are ratified and confirmed as being true and correct and are incorporated in this Resolution.

<u>Section 2</u>: That it approves and authorizes the execution, by the appropriate City officials, of a Blanket Purchase Agreement with Pantropic Power, Inc., together with such non-material changes as may subsequently be agreed to by the City Manager and approved as to form by the City Attorney.

<u>Section 3</u>: That this Resolution shall be in full force and effect immediately upon its passage and adoption.
