Whereas, the City and Langan Engineering and Environmental Services, Inc. entered into a Professional Continuing Services Agreement dated November 20, 2021 ("Original Agreement") for professional engineering services; and

Whereas, Langan Engineering and Environmental Services, Inc., filed a Certificate of Conversion with the State of New Jersey Department of Treasury on January 8, 2024 for conversion from a New Jersey Corporation to a New Jersey Limited Liability Company or more specifically from Langan Engineering and Environmental Services, Inc. to Langan Engineering and Environmental Services, LLC; and

Whereas, Consultant filed an Application by Foreign Limited Liability Company for Authorization to Transact Business in Florida on February 5, 2024; and

Whereas, this First Amendment accomplishes a change of Consultant's name only and all rights and obligations of the City and of the Consultant under the Original Agreement are unaffected by this change.

NOW THEREFORE, in consideration of the promises, mutual covenants, provisions and undertakings contained and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties agree to as follows:

- 1. That the foregoing "Whereas" clauses are ratified and confirmed as being true and correct and incorporated herein.
- 2. The Original Agreement covered by this First Amendment is amended by substituting the name "Langan Engineering and Environmental Services, Inc." for the name "Langan Engineering and Environmental Services, LLC" wherever it appears in the Original Agreement; and

3. That except as amended herein, the City and Consultant ratify, approve and reaffirm the terms of the Original Agreement, and the Original Agreement shall remain in full force and effect, except as amended herein. In the event of any conflict or ambiguity by and between the terms and provisions of the Original Agreement and this First Amendment, the terms and provisions of this First Amendment shall control to the extent of any such conflict and ambiguity.
