RESOLUTION NO

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, APPROVING AND AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO EXECUTE AN AGREEMENT WITH PRO-SECUR, INC. FOR ARMED AND UNARMED SECURITY GUARD SERVICES IN AN AMOUNT NOT TO EXCEED \$10,103,832.50 OVER A FIVE-YEAR PERIOD.

WHEREAS, the Office of the City Manager desires to provide armed and unarmed security guard services ("Security Guard Services") for use by various City departments and facilities; and

WHEREAS, Section 38.43 of the Procurement Code states that when the estimated annual cost of goods, supplies, materials, equipment, or services exceeds \$50,000.00, a formal solicitation process shall be completed that may result in a written contract(s) and/or purchase order(s), after due public notice inviting bids or proposals; and

WHEREAS, on January 23, 2023, in accordance with Section 38.43(A) of the Procurement Code, Invitation for Bid Number IFB-043-23-SK ("IFB") was electronically advertised on OpenGov.com to solicit Security Guard Services; and

WHEREAS, the IFB resulted in bids from the following eight vendors by the response due date, with the lowest lump sum price being the highest ranked as follows:

- 1. Consumer Investigations, Inc., d/b/a Protection Bureau
- 2. Blue Shield Security & Protection, Inc. ("Blue Shield")
- 3. Pro-Secur, Inc. ("Pro-Secur")
- 4. Dynamic Integrated Security, Inc.
- 5. Four Knights Security and Protection, Inc.
- 6. American Guard Services, Inc.
- 7. Kent Security Services, Inc.
- 8. JamPol Protective Services, Inc.; and

WHEREAS, Consumer Investigations, Inc., d/b/a Protection Bureau, was determined to be responsive; however, they were found to be non-responsible in lacking the desired qualifications and resources to provide Security Guard Services; and

WHEREAS, Blue Shield was determined to be the lowest responsive and responsible bidder; and

WHEREAS, the City Commission passed Resolution No. R-2023-191 on June 21, 2023, authorizing the City to enter into a five-year agreement with Blue Shield in an amount not to exceed \$8,030,871.00; and

WHEREAS, following award of the Agreement on August 1, 2023, the City determined in February 2024 that Blue Shield could not meet the level of service required in the Agreement, and exercised its contractual right to terminate its Agreement with Blue Shield, for convenience, effective March 11, 2024; and

WHEREAS, Resolution No. R-2023-191 authorizes the City Commission to execute an agreement with the next lowest responsive and responsible bidder, if the lowest bidder is no longer able to provide Security Guard Services at any time during the term of the Agreement; and

WHEREAS, the Office of the City Manager and Chief Procurement Officer recommend that the City Commission authorize the execution of an agreement with the next lowest responsive and responsible bidder, Pro-Secur, in an amount not to exceed \$10,103,832.50 over a term of five years, which includes an initial term of three years and an option to renew for two additional one-year periods, to provide Security Guard Services ("Agreement"); and

WHEREAS, the City Manager and Chief Procurement Officer recommend that the City Commission authorize the execution of the Agreement with the next lowest responsive and responsible bidder, if the lowest bidder is no longer able to provide Security Guard Services at any time during the term of the Agreement with the lowest bidder; and

WHEREAS, a portion of the funding for this service is available in the FY 2024 Operating Budget in account numbers 001.300301.57500.531170.000000.000.000, 001.204401.52100.531170.000000.000, 446.150201.54500.534780.000000.000, 114.140301.52400.534980.000000.000, 446.150202.54500.534780.000000.000, 446.150203.54500.534780.000000.000, 446.150204.54500.534780.000000.000, 442.400501.53600.531170.000000.000, and will be budgeted in subsequent fiscal years' operating budgets subject to approval and adoption by the City Commission.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA.

<u>Section 1</u>: That the foregoing "WHEREAS" clauses are ratified and confirmed as being true and correct and are incorporated in this Resolution.

<u>Section 2</u>: That it authorizes the execution, by the appropriate City officials, of the attached Agreement with Pro-Secur or the next lowest responsive and responsible bidder, together with such non-material changes as may subsequently be agreed to by the City Manager and approved as to form by the City Attorney.
