A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, AUTHORIZING AN EXPENDITURE OF LAW ENFORCEMENT FORFEITURE FUNDS TO PURCHASE ONE (1) POLICE CANINE IN AN AMOUNT NOT TO EXCEED \$14,500.00; AUTHORIZING THE RECOGNITION OF REVENUE AND APPROPRIATION OF NET ASSETS IN FUND 12 TO VARIOUS LINE ITEMS AS DETAILED IN THE ATTACHED EXHIBIT 1; AND FURTHER AUTHORIZING THE DEPARTMENT OF FINANCIAL SERVICES TO ESTABLISH ACCOUNT(S) AS MAY BE NEEDED.

WHEREAS, the Police Department desires to purchase one (1) police canine to replace an aging canine (Roan) that will be retired after providing service to the City of Hollywood Police Department for the last eight (8) years; and

WHEREAS, the funding source for the purchase of this police canine will be Law Enforcement Forfeiture Funds and therefore, this expense will incur no cost to the taxpayers of the City of Hollywood; and

WHEREAS, the purchase of police canine has normally not been a budgeted expense and has been determined to be a legitimate and permissible law enforcement forfeiture fund expenditure as prescribed by federal guidelines; and

WHEREAS, the Department of Financial Services is hereby authorized to create certain accounts and to recognize revenue and appropriate program funding; and

WHEREAS, the Chief of Police recommends that an amount not to exceed \$14,500.00 be made available from the Law Enforcement Forfeiture Fund in order to purchase one (1) police canine;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:

Section 1: That it hereby approves and authorizes the expenditure of Law Enforcement Forfeiture Funds in order to purchase one (1) police canine in an amount not to exceed \$14,500.00.

RESOLUTION – PURCHASE ONE POLICE CANINE

Section 2: That it hereby authorizes the Department of Financial Services to create certain accounts and to recognize revenue and appropriate program funding.

Section 3: That this Resolution shall be in full force and effect immediately upon its passage and adoption.
