Review existing plans, policies, procedures, and laws that impact affordable housing development.



Recommend improvements to existing policies or create new incentives that encourage/facilitate affordable housing.



Produce a report that recommends and evaluates, at minimum, the 11 incentives required by s. 420.9076(4).



Approve the final report by "affirmative vote of a majority of the membership of the [AHAC] taken at a public hearing."

#### SUMMARY OF AHAC INCENTIVE STRATEGIES RECOMMENDATIONS

- Expediting plan review, inspections and permits for affordable housing projects
- Exploring impact fees strategies
- Supporting flexibility regarding affordable housing projects
- Support affordable housing and mixed-use developments near transportation hubs and employment centers
- Explore opportunities to increase the supply of affordable housing
- Continue to investigate opportunities to fund the Affordable Housing Trust Fund



#### Housing Needs Assessment and Strategic Action Plan

- The City issued a Request for Proposals, RFP-147-24-SK "Housing Needs Assessment and Strategic Action Plan" to be included as part of the City's Comprehensive Plan.

  - ➤ Housing Demand Report
  - ➤ Strategic Housing Action Plan
