The lowest bidder shall be considered the primary vendor and should receive the largest volume of work. Therefore, it is necessary to bid on all items in every group to be considered for award. The City of Hollywood reserves the right to procure from the second or third lowest bidder if: a) the lowest bidder cannot comply with requirements or specifications; b) the lowest bidder is not in compliance with requirements or specifications on current or previous orders; c) in cases of emergency; d) if it is in the best interest of the City to do so regardless of reason.

Please review and evaluate the bid documents submitted to ensure that the bids submitted meet Public Work's service requirements, licensing requirements, budget, and check their references. Forward any questions, clarifications or comments to Procurement Services as the Cone of Silence remains in effect. Once your review and evaluation process is completed, please forward your award recommendation(s) to Procurement Services so we can prepare the required award documents.

If you request that a contract be awarded to a vendor other than the lowest bidder(s), a justification must be prepared and forwarded to Procurement Services.
