A RESOLUTION OF THE CITY COMMISSION OF THE CITY
OF HOLLYWOOD, FLORIDA, APPOINTING THREE
MEMBERS TO THE ARTWORK SELECTION COMMITTEE.

WHEREAS, the City of Hollywood Artwork Selection Committee was created in June 1994 to review, select and display appropriate artwork, including photography, loaned or donated to the City for exhibition on the walls of the foyers and corridors of City Hall at 2600 Hollywood Boulevard, Hollywood, Florida; and

WHEREAS, the duties of the expanded committee include reviewing artwork that could be acquired by the City through commission, donation, or purchase for placement within City facilities; and

WHEREAS, the Artwork Selection Committee is comprised of nine members who are from the artistic and cultural community, are associated with artists in various media in Florida, and have leadership in numerous cultural organizations, which is an essential component when selecting board members to attract new talent to City Hall; and

WHEREAS, presently Alain Dezii and Larry Joe Miller serve on the Artwork Selection Committee, and their terms expire on June 30, 2018; and

WHEREAS, there has been no Member for the Art & Culture Center category since June 30, 2016; and

WHEREAS, the City Clerk provided notice to the public that positions were available and solicited interest forms from the community to fill the current vacancies; and

WHEREAS, the following individuals have expressed a desire and willingness to fill the vacancies and serve on the Committee:

WHEREAS, Laura Marsh, representative for the Art and Culture Center, has expressed a desire and willingness to serve on the Committee.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:
