A RESOLUTION OF THE CITY COMMISSION OF THE CITY  
OF HOLLYWOOD, FLORIDA, CANCELLING SOLICITATION  
IFB-113-23-GJ RELATED TO THE PURCHASE OF DELL  
LATITUDE 5430 RUGGED LAPTOPS FOR THE  
COMMUNITY CENTER COMPUTER LABS.

WHEREAS, the Department of Parks, Recreation & Cultural Arts ("PRCA") desires to purchase Dell Latitude 5430 Rugged Laptops for community center computer labs to upgrade existing desk top computers; and

WHEREAS, on August 15, 2023, the City followed the formal solicitation procedures outlined in Section 38.43 of the Procurement Code to advertise IFB-113-23-GJ Solicitation for Dell Latitude 5430 Rugged Laptops for Computer Lab ("Solicitation") on [www.OpenGov.com](http://www.OpenGov.com); and

WHEREAS, the City received 17 bids in response to the Solicitation by the bid due date of September 5, 2023; and

WHEREAS, during the evaluation process, PRCA was advised that projects funded under the CARES Act's supplemental funds, CDBG-CV2, were placed on hold pending final approval by Florida Commerce ("Commerce"); and

WHEREAS, PRCA will issue a new solicitation after Commerce approves the release of funding; and

WHEREAS, the Solicitation allows for the cancellation of any and all responses; and

WHEREAS, Section 38.43(D) of the Procurement Code states that when any goods, supplies, materials, equipment or services shall be purchased and the estimated annual amount exceeds \$100,000.00, the Chief Procurement Officer shall have the authority to recommend to the City Manager, for City Commission consideration, the rejection or cancellation of all bids or proposals, or parts of all bids or proposals for any one or more goods, supplies, materials, equipment or services; and

WHEREAS, the Director PRCA and Chief Procurement Officer recommend that the City Commission cancel the Solicitation.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, CANCELLING SOLICITATION IFB-113-23-GJ RELATED TO THE PURCHASE OF DELL LATITUDE 5430 RUGGED LAPTOPS FOR THE COMMUNITY CENTER COMPUTER LABS.

Section 1: That the foregoing "WHEREAS" clauses are ratified and confirmed as being true and correct and are incorporated in this Resolution.

Section 2: That City staff is directed to cancel solicitation IFB 113-23-GJ.

Section 3: That this Resolution shall be in full force and effect immediately upon its passage and adoption.
