3. I believe a multi-pronged approach to growing the City's tax base, that includes but is not limited to (1) focusing on commercial development along the commercial corridors which can have a tremendous impact on the City's tax base, (2) educating our City's residents that through re-investment in their homes and neighborhoods the return on their investment will become self-evident, and (3) heightened enforcement of the existing code to remind owners that they have a responsibility to maintain their properties, can drive that engine of growth in the City's tax base, and not at the expense of neighborhood stabilization.

4. There are two major, recent developments in the City that I am most proud of. The first is Hollywood Circle, the newest development on the Circle that I think will bring much needed density to the Downtown area. ## POLICE OFFICER'S PENSION BOARD

1. A fiduciary is a person who is responsible for the duties and responsibilities of making sure the pension funds are properly invested with investors who follow the state guidelines. Also as a pension Board member it is utmost important to hire those individuals to make sure that all state and local rules are followed.
2. The sunshine law is a state law that makes sure all elected officials conduct all duties and responsibilities are carry out in an open forum.
3. Asset Allocation and Diversification is set by state guidelines making sure the investments of the pension funds are properly invested.
4. Chapter 99-1 and Chapter 185 were state laws passed to protect local pension plans in setting minimum standards of benefits. 185 money (or refer to as 1% money) is money that the state collects from auto insurance companies to help provide extra benefits (above the minimum) for local police pension plans. Presently the city of Hollywood's share is approximately 1.3 million dollars.
5. The actuary is a specialized field in someone who projects the cost of a benefit that is allowed in the pension plan. An Auditor is a person who watches over the spending of any pension funds.
