9/30/20 Closed at time of inspection. Amsterdam is a nightclub that opens at 2100hours. It will be inspected by officers over the weekend. 10/2/20- At 9:15pm PD and Code inspected Amsterdam Bar, they were given a warning for hookah smoking.

Inspected 10/12/20- Amsterdam was not open during the time of inspection. I did leave a business card for contact with an employee to discuss the complaint and forwarded to the weekend workers to investigate more. UNFOUNDED

10/18/20- Inspected at 10:30 pm. No social distancing at the bar and hookah bar. A verbal warning was issued.

10/23/20- Social distancing and mask guidelines were being followed. PD to monitor after hours regulations.

10/29/20- Inspected between 12:30am-1:30am Thursday evening. Business was in full swing with no intention of shutting down/abiding by Broward County Emergency Orders. Music and partying seemed to increase after inspection by City.

10/31/20- Police responded and shut down business due to no social distancing. \$5,000 Admin Citation sent to owner as well.

11/6/20- Amsterdam was inspected tonight at around 11:55pm and they were at or above 100 % capacity with no social distancing. They had no intention to abide by the 12am county timeframe. A \$5000 Admin citation will be mailed for no social distancing

Inspection conducted on 12/11/20 at approx. 9:30pm. Officer Weitzner witnessed no egregious safety guidelines at this time. The interior of the business did not have any capacity issues or crowd concerns at this time. All employees inside and the person at the front door had facial masks on. There was working hand sanitizer near the front entrance door and near the restroom area. Social distancing markings were visible outside near the front door and the front doorman advised they have a temperature reader and take peoples temperature before they are allowed to enter. He also showed a packet of masks and hand them out to anyone who arrives without a mask, yet states that some people refuse and say 'they will be drinking inside'. Officer Weitzner explained that all customers must wear masks to enter and anytime they are not actively eating or drinking inside. The door person explained that they enforce this "as best they can". The front doorman says they turn up the lights at closing time and advise people to leave as the club is closed per County regulation. He says they are 'always getting complaints because of rival businesses' and that the police are there often re any issues, crowds, noise, etc. No citations issued at time of on site inspection.

12/13/20- Tekila Bar. Inspected at approximately 9:45 pm. No violation found at the time of inspection. Amsterdam was inspected at 10:37pm. We observed patrons walking around and dancing without masks- case was referred to Supervisor Robinson for CU revocation file.

Investigated at 10:55 pm, 12/19/20 – no evidence of violations were identified.

12/20/20 Referred to Hollywood PD.

12/22/20- Dear Resident, City Inspectors have investigated every one of your complaints. Amsterdam has open Citations pending and each complaint that results in the officers identifying an issue, has been added to the case file. The business will be scheduled to appear before the Special Magistrate, where the City will seek a Lien Imposition on this property. Amsterdam continues to be monitored by Code and Police. Thank you.
