As consultant to the City of Hollywood and Engineer of Record on the above referenced project, Kimley-Horn and Associates, Inc. has completed its review of the bids received by the City for bid 12-5114. As stipulated in the Contract Documents, the following criteria were used to evaluate bids:

- 1) Verification of receipt of documentation and Information Required from Bidders:
  - a. Signed Proposal (Section 00300, including acknowledgment of receipt of all three addendums)
  - b. Proposal Bid Form (Section 00301)
  - c. Approved bid bond (Section 00410)
  - d. Information Required from Bidders (Section 00420) (refer to checklist in Attachment 1)
  - e. Trench safety form (Section 00495)
- 2) Tabulation of the bids received, comparative review of unit costs provided, and verification of totals
- 3) References for a minimum of three different projects of similar nature and magnitude as the subject project completed within the previous seven years
- 4) Qualifications and references of the Bidder's project manager and project superintendent for two different projects of similar nature and magnitude as the subject project and completed within the previous seven years
- 5) Proof of ownership of equipment
- 6) Proof of experience with public outreach
- 7) Proof of current local municipal continuing services contract to perform work similar to the subject project
- 8) Past project performance issues, if known to KHA
- 9) Present workload and current ongoing projects



- 10) Any payments, taxes, licenses or other moneys currently owed by the bidder to the City of Hollywood, if known to KHA
- 11) Information regarding any defaulted contracts with the City, and any litigation between the bidder and the City, if known to KHA

Upon tabulation of the bids and review of information received, KHA finds that the lowest responsive bidder is David Mancini and Sons, Inc., (DMSI) of Pompano Beach, Florida.

Based on all the information collected and made available to KHA, and in accordance with the criteria established by the City of Hollywood for contractor evaluation and selection on the above referenced bid, it is our professional opinion that David Mancini and Sons, Inc. has provided the necessary documentation, meets the minimum required experience and qualifications, and is the lowest responsive, responsible bidder.
