

**FIRST AMENDMENT TO
FRANCHISE AGREEMENT
Between
CITY OF HOLLYWOOD, FLORIDA
and
FLSC,LLC
for
TEXTILE RECYCLING AND COLLECTION**

This is an Amendment to the Agreement, made and entered into by and between the City of Hollywood (the "CITY"), a Florida municipal corporation, 2600 Hollywood Boulevard, Hollywood, Florida 33020-4807, and FLSC, LLC a Florida limited liability company, d/b/a Florida Textile Recycling Programs, hereinafter referred to as ("CONTRACTOR"). CONTRACTOR maintains an office of business at 135 Weston Road, Suite 319, Weston, FL 33326.

WHEREAS, on November 15, 2017, the City Commission passed and adopted Resolution No. R-2017-351 which authorized the negotiation and execution of a Franchise Agreement (the "Agreement") by and between CITY and CONTRACTOR; and

WHEREAS, CONTRACTOR has requested a modification of the Agreement due to its inability to pay the agreed upon amount.

NOW THEREFORE, FOR GOOD AND VALUABLE CONSIDERATION, of the mutual terms, conditions, promises, covenants, and payments hereinafter set forth, CITY and CONTRACTOR agree to amend section 4.1 as follows:

4.1 FRANCHISE FEES

The Franchise Fees/Payments shall be paid as follows:

Beginning May 1, 2019, CONTRACTOR shall pay \$62,500.00 to the CITY in equal installments on the 1st day of each month. For any additional bins beyond 50 bins, the CONTRACTOR shall pay \$2,000 per year per bin to the CITY. Commencing October 1st and yearly thereafter, the guaranteed revenue stated above, will be adjusted in accordance with the Consumer Price Index- All Urban Consumers' (Series IDCUURA320SAO and CUUSA320SAO) for Miami-Fort Lauderdale as published by the US Department of Labor, Bureau of Labor Statistics, or successor agency.
