A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, APPROVING AND AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO EXECUTE AN INTERLOCAL AGREEMENT WITH BROWARD COUNTY TO SUPPORT GROWTH MANAGEMENT AND MONITORING OF APPROVED DEVELOPMENTS WITHIN THE OAKWOOD ACTIVITY CENTER.

WHEREAS, the City of Hollywood desires to enter into an Interlocal Agreement ("ILA") with Broward County for the monitoring of growth of the Oakwood Activity Center; and

WHEREAS, the general purpose of the ILA is to develop and implement a long-term, environmentally sustainable, transparent, innovative, and economically efficient approach to development in Broward County; and

WHEREAS, a Local Land Use Plan Amendment created the Oakwood Activity Center on July 5, 2023 (O-2023-09); and

WHEREAS, the City acknowledges the importance of efficient land use and the need for cooperation between local entities to achieve mutual objectives; and

WHEREAS, the City recognizes that the monitoring of development activity and the enforcement of permitted land uses within the Oakwood Activity Center should be executed in compliance with the Broward County Land Use Plan; and

WHEREAS, pursuant to Section 163.01, Florida Statutes, the Florida Interlocal Cooperation Act of 1969, the City and Broward County seek to collaborate on matters of mutual interest and advantage, as provided for in the attached ILA.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:

<u>Section 1</u>: That the foregoing "WHEREAS" clauses are ratified and confirmed as being true and correct and are incorporated in this Resolution.

Section 2: That the City Commission approves and authorizes the appropriate City officials to execute the ILA with Broward County to support the approved development at the Oakwood Activity Center, in accordance with the terms and conditions outlined in the ILA.

<u>Section 3</u>: That the City Manager is authorized and directed to execute the ILA on behalf of the City, and to take any further actions necessary to implement the terms and conditions of the ILA.

<u>Section 4</u>: That the City Commission affirms its commitment to the efficient use of powers and resources by collaborating with Broward County under the Florida Interlocal Cooperation Act of 1969, and the City and Broward County shall work together to achieve the objectives outlined in the ILA, promoting responsible development and adherence to the Broward County Land Use Plan within the Oakwood Activity Center.

<u>Section 5</u>: That this Resolution shall be in full force and effect immediately upon its passage and adoption.
