A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, APPROVING THE ATTACHED STATE HOUSING INITIATIVES PARTNERSHIP PROGRAM FINAL ANNUAL REPORT (SHIP-AR) FOR FISCAL YEAR 2013/2014, AND INTERIM ANNUAL REPORTS FOR FISCAL YEARS 2014/2015 AND 2015/2016, PURSUANT TO THE STATE HOUSING INITIATIVES PARTNERSHIP PROGRAM ACT; AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO TRANSMIT THE ATTACHED SHIP-AR TO THE FLORIDA HOUSING FINANCE CORPORATION; AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO EXECUTE ANY AND ALL REQUIRED DOCUMENTS FOR THE SHIP-AR; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the State of Florida enacted the William E. Sadowski Affordable Housing Act, Chapter 92-317 of Florida Sessions Laws, allocating a portion of documentary stamp taxes on deeds to local governments for the development and maintenance of affordable housing; and

WHEREAS, the State Housing Initiatives Partnership ("SHIP Act"), Sections 420.907-420.9079, Florida Statutes, and Rule 67-37, Florida Administrative Code, require local governments to develop a one- to three-year Local Housing Assistance Plan outlining how the allocated funds will be used; and

WHEREAS, the SHIP Act further requires local governments to annually report on the new and existing housing which benefits from awards made pursuant to the SHIP Act; and

WHEREAS, the Department of Development Services has prepared the attached SHIP-AR for transmission to the Florida Housing Finance Corporation; and

WHEREAS, the City Commission finds that it is in the best interest of the public for the City of Hollywood to transmit the attached SHIP-AR for review and approval by the Florida Housing Finance Corporation in order to satisfy the requirements of the SHIP Act;

NOW THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:

Section 1: That it hereby approves the attached final annual SHIP-AR for Fiscal Yyear 2013/2014, and interim annual reports for Fiscal Years 2014/2015 and 2015/2016.

Section 2: That the Director of the Department of Development Services is hereby authorized and directed to transmit the attached SHIP-AR to the Florida Housing Finance Corporation.

Section 3: That the appropriate City Officials are hereby authorized to execute any and all documents and certifications required by the Florida Housing Finance Corporation as they relate to the attached SHIP-AR and to take such actions necessary to implement the attached SHIP-AR.

Section 4: That this resolution shall be in full force and effect immediately upon its passage and adoption.
