ORIGINAL AGREEMENT FOR THE SECOND OF THREE
ALLOWABLE OPTIONS, AND TO INCREASE THE RATES,
SUBJECT TO THE TERMS AND CONDITIONS OF THE
ORIGINAL AGREEMENT; PROVIDING FOR CONFLICTS;
PROVIDING FOR SEVERABILITY; AND PROVIDING AN
EFFECTIVE DATE.

17 **WHEREAS**, the City Commission of the City of Wilton Manors deems it to be in
18 the best interests of the public to execute the Third Amendment to the Agreement with
19 Calvin, Giordano & Associates, Inc. to extend the term of the Original Agreement for the
20 second of three allowable options, and to increase the rates, subject to the terms and
21 conditions of the Original Agreement.

22 NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION
23 OF THE CITY OF WILTON MANORS, FLORIDA, THAT:

24 Section 1. The "WHEREAS" clause set forth above is true and correct and
25 incorporated herein by this reference.

26 Section 2. The City Commission of the City of Wilton Manors hereby approves
27 the terms and conditions of the Third Amendment to the Agreement with Calvin, Giordano
28 & Associates, Inc., said Amendment having been submitted for consideration to the City
29 Commission in written form.

30 Section 3. The proper City Officials of the City of Wilton Manors are hereby
31 authorized and directed to execute the Amendment.

1 **Section 4.** All Resolutions or parts of Resolutions in conflict herewith, be and the
2 same are repealed to the extent of such conflict.

3 **Section 5.** If any section, sentence, clause or phrase of this Resolution is held to be
4 invalid or unconstitutional by any court of competent jurisdiction, then said holding shall
5 in no way affect the validity of the remaining portions of this Resolution.

6 **Section 6.** This Resolution shall become effective immediately upon its passage
7 and adoption.

THIRD AMENDMENT TO
GENERAL PLANNING CONSULTING SERVICES AGREEMENT

gda **THIS THIRD AMENDMENT TO AGREEMENT** ("Amendment"), dated the _____ day of December, 2025, between:

THE CITY OF WILTON MANORS, a Florida municipal corporation,
hereinafter referred to as "CITY",
and

CALVIN, GIORDANO & ASSOCIATES, INC. a Florida corporation,
hereinafter referred to as "CONSULTANT".

WHEREAS, on or about December 13, 2022, the CITY entered into an agreement with CONSULTANT for general planning and consultant services (the "Original Agreement"); and

WHEREAS, on or about August 27, 2024, the CITY entered into a First Amendment to the Original Agreement; and

WHEREAS, on or about December 10, 2024, the CITY entered into a Second Amendment to the Original Agreement; and

WHEREAS, CITY and CONSULTANT now desire to amend the Original Agreement, as amended, to extend the term of the Agreement for the second of three (3) one (1) year options and to increase the rates, subject to the terms and conditions of the Original Agreement.

NOW, THEREFORE, in consideration of the mutual promises, covenants, and agreements herein contained, and other good and valuable consideration, the receipt and sufficiently of which are hereby acknowledged, the CITY and CONSULTANT agree to amend the Original Agreement as follows:

- 1. RECITALS:** Each "Whereas" clause set forth above is true and correct and incorporated herein by this reference.
- 2. TERMS:** Pursuant to Section 5.2 of the Original Agreement, as amended, the term of the Original Agreement shall be renewed for the second of three (3) one year (1) allowable option terms commencing December 13, 2025 and ending on December 12, 2026.
- 3. RATES:** Pursuant to Section 5.2 of the Original Agreement, as amended, commencing on December 13, 2025, the rates provided for in Section 3.1 of the Original Agreement shall be amended as follows:

Exhibit "A" of the Original Agreement is replaced with Exhibit "A" attached hereto.

4. SCRUTINIZED COMPANIES: CONSULTANT, its principals or owners, certify that they do not Participate in a boycott of Israel, are not listed on the Scrutinized Companies or Other Entities that Boycott Israel List, Scrutinized Companies with Activities in Sudan List, Scrutinized Companies with Activities in the Iran Terrorism Sectors List, or are engaged in business operations with Cuba or Syria. In accordance with §287.135, Florida Statutes, as amended, a company is ineligible to, and may not, bid on, submit a proposal for, or enter into or renew a contract with any agency or local governmental entity for goods or services of:

- a. \$100,000.00 or more if, at the time bidding on, submitting a proposal for, or entering into or renewing such contract, the company is on the Scrutinized Companies that Boycott Israel List, created pursuant to §215.4725, Florida Statutes, or is engaged in a boycott of Israel; or
- b. One million dollars or more if, at the time of bidding on, submitting a proposal for, or entering into or renewing such contract, the company:
 - i. Is on the Scrutinized Companies with Activities in Sudan List or the Scrutinized Companies with Activities in the Iran Terrorism Sectors List, created pursuant to §215.473, Florida Statutes; or
 - ii. Is engaged in business operations in Cuba or Syria.

5. ORIGINAL AGREEMENT: All of the terms and conditions of the Original Agreement as amended from time to time shall be binding and remain in full force and effect except as expressly amended hereinabove.




