A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO ISSUE A PURCHASE ORDER TO THE PETERBILT STORE SOUTH FLORIDA LLC D/B/A THE PETERBILT STORE FOR THE PURCHASE OF A 2026 PETERBILT 520 REAR LOADER GARBAGE TRUCK IN AN AMOUNT UP TO \$335,120.00 BASED UPON SOURCEWELL CONTRACT #032824-PMC PETERBILT CLASS 4-8 CHASSIS AND CABS IN ACCORDANCE WITH SECTION 38.41(C)(5) OF THE PROCUREMENT CODE. (PIGGYBACK)

WHEREAS, the Department of Public Works ("Public Works") is responsible for keeping the beaches clean, eliminating seaweed, removing debris, setting up and breaking down of various events, clearing city streets, and property, and responding to emergency situations such as hurricanes and other natural disasters; and

WHEREAS, Public Works needs to replace the existing unit which has become severely rusted, outdated, and has exceeded its expected service life; and

WHEREAS, due to years of heavy use and exposure to harsh environmental conditions, the vehicle's structural integrity and mechanical components have significantly deteriorated, resulting in increased maintenance costs and frequent downtime; and

WHEREAS, replacing the truck will ensure continued service reliability, reduce repair expenses, and improve overall operational efficiency; and

WHEREAS, the new garbage truck will also enhance safety for our staff and support the department's ability to meet service demands effectively; and

WHEREAS, the 2026 Peterbilt 520 Rear Loader Garbage Truck was competitively bid by Sourcewell through Solicitation #032824 Peterbilt Class 4-8 Chassis and Cabs on February 8, 2024 and awarded to The Peterbilt Store South Florida LLC d/b/a The Peterbilt Store ("The Peterbilt Store") under Sourcewell Contract 032824-PMC Peterbilt Class 4-8 Chassis and Cabs; and

WHEREAS, the current term of the Sourcewell Contract 032824-PMC Peterbilt Class 4-8 Chassis and Cabs is for a four-year initial term from July 5, 2024, to July 9, 2028, with three one-year renewal terms; and

WHEREAS, Section 38.41(C)(5) of the Procurement Code allows the Chief Procurement Officer to procure, without formal solicitation procedures, all goods, supplies, materials, equipment, and services that are the subject of contracts with the state, its political subdivisions, the United States government, other governmental entities, or a corporation not for profit whose members are governmental entities, public officers, or any combination thereof ("piggyback"), provided that the goods, supplies, materials, equipment, or services are the subject of a price schedule negotiated by the entities listed above and is based strictly on competitive bids, quotations, or competitive proposals and not on any preference and such utilization of other governmental entities contracts shall be permitted only during the term of the other governmental entity's contract; and

WHEREAS, the Director of Public Works and the Director of Procurement and Contract Compliance recommend that the City Commission approve and authorize the issuance of the attached Purchase Order to The Peterbilt Store for the purchase of a 2026 Peterbilt 520 Rear Loader Garbage Truck up to \$335,120.00; and

WHEREAS, funding for the purchase of the Rear Loader Garbage Truck was included in the amended FY 2026 Capital Improvement Plan, and is available in account number 445.519901.51900.564520.000117.000.000.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA.

Section 1: That the foregoing "WHEREAS" clauses are ratified and confirmed as being true and correct and are incorporated in this Resolution.

Section 2: That it approves and authorizes the issuance, by the appropriate City officials, of the attached Purchase Order with The Peterbilt Store South Florida LLC d/b/a The Peterbilt Store, together with such non-material changes as may subsequently be agreed to by the City Manager and approved as to form and legal sufficiency by the City Attorney.
