A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, AMENDING THE SPECIAL PROGRAMS FUND (FUND 11) OF THE FISCAL YEAR 2015 ADOPTED BUDGET (R-2014-282), REVISING AND RECOGNIZING CERTAIN OPERATING REVENUES, AUTHORIZING CERTAIN BUDGETARY REAPPROPRIATIONS AND REALLOCATIONS AS DETAILED IN THE ATTACHED EXHIBIT 1, AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, certain routine and periodic budgetary adjustments and transfers are appropriate and necessary; and

WHEREAS, certain programs and services extend from fiscal year to fiscal year and require an uninterrupted and continuing source of appropriated funds in Special Program Fund (Fund 11) line item accounts to provide necessary and required services and program funding in order to assist staff in meeting program objectives and requirements; and

WHEREAS, operational requirements necessitate certain revisions to the Adopted Fiscal Year 2015 Budget to promote greater productivity, effectiveness, and efficiency; and

WHEREAS, the completion of the audit for Fiscal Year 2014 allows for the reconciliation of budgeted amounts of net assets to actual audited amounts.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:

Section 1: That these Amendments, Adjustments and Reappropriations to the Special Programs Fund (Fund 11) Operating Budget of the City of Hollywood for the Fiscal Year beginning October 1, 2014, and set forth in detail in Exhibit 1 are hereby approved, adopted and authorized as Amendments to the Special Programs Funds Operating Budget of the City of Hollywood Florida, for the Fiscal Year 2015.

Section 2: That this resolution shall be in full force and effect immediately upon its passage and adoption.
