A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, APPROVING AND AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO EXECUTE A PROPERTY ACCESS AGREEMENT WITH STORAGE EXPRESS III LLC FOR THE PURPOSE OF INSTALLING, OPERATING AND MAINTAINING THE CITY'S AUTOMATED LICENSE PLATE RECOGNITION AND CLOSED-CIRCUIT TELEVISION EQUIPMENT.

WHEREAS, the Police Department continues to expand its technology program to supplement operations and investigations and determined that Storage Express III LLC would be a viable location to install, operate and maintain Automated License Plate Recognition ("ALPR") and CCTV equipment; and

WHEREAS, Storage Express III LLC has agreed to allow the City to use a portion of their property to install ALPR Equipment pursuant to the Property Access Agreement; and

WHEREAS, the Chief of Police recommends that the City Commission approve and authorize the appropriate City officials to execute the Property Access Agreement with Storage Express III LLC.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:

Section 1: That the foregoing "WHEREAS" clauses are ratified and confirmed as being true and correct and are incorporated in this Resolution.

Section 2: That it authorizes the execution, by the appropriate City officials, of the Property Access Agreement with Storage Express III LLC, together with such non-material changes as may be subsequently agreed to by the City Manager and approved as to form.

Section 3: That this Resolution shall be in full force and effect immediately upon its passage and adoption.
