A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, APPROVING AND AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO ISSUE PURCHASE ORDERS TO AUTO NATION CHEVROLET, STINGRAY CHEVROLET, DUVAL FORD, LLC, ALAN JAY CHEVROLET, INC., AND PALMETTO FORD TRUCK SALES, INC., FOR THE PURCHASE OF VEHICLES FOR THE PUBLIC UTILITIES DEPARTMENT IN THE TOTAL AMOUNT OF \$498,245.75.

WHEREAS, the Public Utilities department requires 13 new vehicles to replace a portion of their aging fleet, such vehicles being used for maintenance and operational services; and

WHEREAS, the 13 new vehicles requested are as follows: One 2018 Chevrolet Express 2500 Cargo Van from Auto Nation Chevrolet costing \$25,075.00; Two 2018 Chevrolet Express 3500 HD Crew Cab Service Body Trucks from Auto Nation Chevrolet costing \$97,732.00; One 2018 Chevrolet City Express Cargo Mini Van from Stingray Chevrolet costing \$24,341.00; Five 2019 Ford Pickup Truck 4X2 from Duval Ford, LLC costing \$129,010.00; Three 2018 Chevrolet Silverado 3500 HD Service Body Trucks from Alan Jay Chevrolet, Inc. costing \$116,619.75; and One 2019 Ford F-550 4X2Truck with Crane Body from Palmetto Ford Truck Sales, Inc. costing \$105,468.00; and

WHEREAS, on October 13, 2017, the Florida Sheriffs Association approved and authorized the award of Bid Number FSA17-VEL25.0 for Police Rated, Administrative, Utility vehicles, Trucks, and Vans for a term effective from December 20, 2017 through September 30, 2018; and

WHEREAS, on October 13, 2017, the Florida Sheriffs Association approved and authorized the award of Bid Number FSA17-VEL15.0 for Cabs & Chassis and Other Fleet Equipment for a term effective from October 13, 2017 through September 30, 2018; and

WHEREAS, bids were requested to establish agreements for various specifications, makes and models; and

WHEREAS, award was made to the lowest and best responsive bidder by specification, by manufacturer, and by zone; and

WHEREAS, Section 38.40 (C)(5) of the City's Purchasing Ordinance allows the Director to procure, without following formal procedures, all goods and services which are subject of contracts with the state, its political subdivisions, the United States government, other governmental entities, or a corporation not for profit whose members are

governmental entities, public officers, or any combination thereof, provided that the goods and services are (i) the subject of a price schedule negotiated by the state or the United States government, or (ii) the subject of a contract with another governmental entity or a corporation not for profit whose members are governmental entities, public officers, or any combination thereof, which contract is based strictly on competitive bids or competitive proposals and not on any preference; and

WHEREAS, the Director of Public Works and the Director of Procurement Services recommend that the City Commission approve the issuance of purchase orders to Auto Nation Chevrolet, Stingray Chevrolet, Duval Ford, LLC, Alan Jay Chevrolet, Inc., and Palmetto Ford Truck Sales, Inc. for 13 vehicles to support Public Utilities maintenance and operational services for a total amount of \$498,245.75; and

WHEREAS, funding for the requested vehicles has been appropriated and exists in account number 57.5100.18106.590.046452.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:

That the foregoing "WHEREAS" clauses are ratified and confirmed Section 1: as being true and correct and are incorporated in this Resolution.

Section 2: That it approves and authorizes the issuance, by the appropriate City officials, of purchase orders to Auto Nation Chevrolet (\$122,807.00), Stingray Chevrolet (\$24,341.00), Duval Ford, LLC (\$129,010.00), Alan Jay Chevrolet, Inc. (\$116,619.75), and Palmetto Ford Truck Sales, Inc. (\$105,468.00), together with such non-material changes as may be subsequently agreed to by the City Manager and approved as to form and legal sufficiency by the City Attorney.

That this Resolution shall be in full force and effect immediately upon Section 3: its passage and adoption.
