SUBJECT: Purchase of Two New Vehicles for Utility Billing Field Service Functions

ISSUE:

The Department of Public Utilities requests the procurement of two (2) 2016 Chevrolet Colorado, 2WD (12M53) Compact Extended Cab 4X2 pickup trucks for the Utility Billing field service functions.

EXPLANATION:

We are in need of two (2) vehicles for the Utility Billing field service functions. In January 2015 Public Utilities took over operations of Utility Billing Field Services from the outside Customer Service contractor DMA. We have been using Underground Utilities Division vehicles to provide these services but our service demand for Utility Billing field service functions necessitate the need for separate vehicles. Back in May, we started the customer Turn-on and Turn-off process in-house and the volume of this activity has been very high so we need new vehicles soon to properly service this demand.

Funds are available from the Motor Vehicles Program (42.4000.90716.536.006452) to be used to purchase the new vehicles. The cost for both vehicles is \$49,524.00 as per the attached Vehicle Quote from the Florida Sheriffs' Association Bid No. 15-23-0904.

ISSUE:

The Department of Public Utilities (DPU) requests a transfer of funds related to procuring replacement vehicle #8018.

EXPLANATION:

The subject vehicle was placed out of service by the Department of Public Works, Fleet Maintenance because of excessive rust on the undercarriage and chassis. Vehicle #8018 is used by the Department of Public Utilities (DPU), Water Quality Services (WQS) Division to perform environmentally sensitive assignments to satisfy permit requirements placed on the City by regulatory agencies (i.e. Department of Health and Florida Department of Environment Protection).
