RESOLUTION NO. R-2025-175

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, APPOINTING TEN MEMBERS, ONE ALTERNATE LOCALLY ELECTED OFFICIAL, AND CREATING THREE ALTERNATE MEMBERS TO THE AFFORDABLE HOUSING ADVISORY COMMITTEE.

WHEREAS, Section 420.9076, Florida Statutes, requires the establishment of an Affordable Housing Advisory Committee comprised of members representing specified categories to review affordable housing policies and recommend strategies to facilitate affordable housing; and

WHEREAS, Section 160.06 of the Hollywood Code of Ordinances ("City Code") created the City's Affordable Housing Advisory Committee ("Committee") in accordance with state law; and

WHEREAS, the Committee recommends specific actions or initiatives to encourage or facilitate affordable housing while protecting the appreciation of property values; and

WHEREAS, the Committee consists of one elected official and no more than 11 members; and

WHEREAS, it is necessary and appropriate to authorize Alternate Members to assume the position of a Regular Voting Member in the event of an absence or vacancy to ensure the Committee maintains full membership and continues its advisory work without disruption provided that the Alternate Member is qualified to represent the designated category of the Regular Voting Member or another applicable category; and

WHEREAS, the City Commission further wishes to allow Alternate Members to participate in Committee votes when needed due to the absence of Regular Voting Members to maintain quorum requirements and support the efficient and continuous functioning of the Committee; and

WHEREAS, the City Commission wishes to establish staggered three-year terms for both Regular and Alternate Members and to allow reappointment for subsequent terms pursuant to Chapter 37 of the City Code; and

WHEREAS, the following seven seats on the Affordable Housing Advisory Committee are currently filled with terms expiring on June 30, 2025:

Residential Affordable Home Building Industry: Henry Graham

For-Profit Provider of Affordable Housing: Mohammad Reza Ronizi

Not-For-Profit Provider of Affordable Housing: Robert Vargas

Real Estate Professional: Shoshana Hill

City of Hollywood Resident Member: Elizabeth Brauser

Citizen Representing Employers: Alex Recio

Citizen Representing Essential Personnel: Marcela Rubio; and
