Subject: Request to execute a 12-month maintenance agreement with Motorola for

fire station alerting and CAD maintenance; affects Police and Fire personnel.

CHRISTOPHE CT. CIES

ISSUE:

The Information Technology Department is requesting to execute a 12-month maintenance agreement with Motorola Solutions, Inc. for servicing the fire station alerting system and CAD user licenses.

EXPLANATION:

Annually Broward County or its public safety manager, the Broward Sheriff's Office, must execute a 12-month maintenance agreement for its fire station alerting and CAD user licenses.

As Motorola is the sole provider for this equipment and software and provides support and maintenance for the Broward Sheriff's Office (BSO) and all Cities in Broward County using their system and equipment, the Broward Sheriff's Office has chosen to execute a 12-month maintenance agreement with Motorola Solutions, Inc.

Motorola will provide the City with 24 x 7 support and maintenance for Fire Station Alerting Control Stations at each of the City's fire stations, Control Stations installed at the City's Emergency Operations Center, Zetron Fire Alerting Systems installed at the fire stations and Computer Aided Dispatch software used by Police and Fire.

Since the hardware and software are proprietary products manufactured and supported by Motorola, and Motorola is providing these services to BSO and all cities in Broward County utilizing this equipment and software based on a negotiated agreement between Broward County and Motorola, I.T. has confirmed the pricing with Broward county and is requesting a "Best Interest" procurement with Motorola in accordance with the appropriate City ordinance(s).

On August 6, 2015, the third amendment to the agreement by and between Sheriff Scott J. Israel of Broward County and Motorola Solutions, Inc. was adopted. This amendment executed a 12-month maintenance agreement between Broward County and Motorola Solutions for the aforementioned services.

A quote from Motorola Solutions, Inc. was provided to execute a 12-month maintenance agreement for fire station alerting and CAD user license maintenance agreements.

WHEREAS, on or about September 12, 2013, the Parties entered into a Master Purchase Agreement; and

WHEREAS, on or about October 31, 2013, the parties entered into a First Amendment; and

WHEREAS, on or about September 24, 2014 the parties entered into a Second Amendment; and

WHEREAS, the Agreement and First Amendment and Second Amendment are hereinafter collectively referred to as the "Agreement"; and

WHEREAS, BSO and MOTOROLA are now desirous of extending the term of the agreement for one additional year after its scheduled termination date of September 30, 2015; and

NOW, THEREFORE, in consideration of the mutual terms and conditions contained herein, the parties agree as follows:

- 1. The foregoing recitations are true and correct and are incorporated herein by reference.
- 2. The term of the Agreement is extended from October 1, 2015 through September 30, 2016.
- 3. All X Series radios discount is 15%.
- 4. MotoTRBO radios discount is 15%.

Except as modified herein, all remaining items and conditions of the Agreement, shall remain in full force and effect.
