A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, APPROVING AND AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO EXECUTE AN INTERLOCAL AGREEMENT WITH THE CITY OF HOLLYWOOD COMMUNITY REDEVELOPMENT AGENCY TO RECEIVE FUNDING FOR CONSTRUCTION ENGINEERING INSPECTION SERVICES IN AN AMOUNT OF \$63,257.04.

WHEREAS, on September 1, 2021, the City Commission passed and adopted Resolution No. R-2021-208, approving and authorizing the appropriate City officials to execute Continuing Services Agreements with various firms to provide construction engineering inspection ("CEI") services, including Carnahan, Proctor and Cross, Inc. ("CPC"); and

WHEREAS, the Department of Design and Construction Management ("DCM") has engaged CPC to provide CEI services for three signage projects being implemented concurrently, the Citywide Gateway and Neighborhood Signage Project (the "GOB Signage Project"), the Beach Community Redevelopment Agency Signage Project (the "BCRA Signage Project"), and the Downtown Community Redevelopment Agency Signage Project (the "DCRA Signage Project") (collectively referred to as "Signage Projects"); and

WHEREAS, the CEI services are being consolidated into a single contract to maximize cost-efficiency, streamline project administration, and promote consistent inspection, management, and quality assurance throughout the installation of approximately 109 signs across the three projects; and

WHEREAS, the Hollywood Community Redevelopment Agency ("CRA"), consisting of the Downtown District and the Beach District, will provide funding to the City in the amount of \$63,257.04, pursuant to the Interlocal Agreement, to support the costs associated with CEI services for the BCRA and DCRA signage components; and

WHEREAS, the Interlocal Agreement sets forth the terms under which the City and CRA will collaborate and share costs for the CEI services, serving a public purpose by supporting the successful delivery and oversight of public infrastructure improvements; and

WHEREAS, funding for this project is available in account numbers 163.639901.55200.563060.001595.000.000 (Beach CRA \$29,069.04) and 166.669902.55200.563010.001107.000.000 (Downtown CRA \$34,188.00).

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:

Section 1: That the foregoing "WHEREAS" clauses are ratified and confirmed as being true and correct and are incorporated in this Resolution.

Section 2: That the City Commission hereby approves and authorizes the appropriate City officials to execute an Interlocal Agreement with the Hollywood Community Redevelopment Agency to receive funding in the amount of \$63,257.04 for construction engineering inspection services, provided by Carnahan, Proctor and Cross, Inc., for the BCRA and DCRA signage components of the Signage Project, together with such non-material changes as may be subsequently approved by the City Manager and approved as to form and legal sufficiency by the City Attorney.

Section 3: That this Resolution shall be in full force and effect immediately upon its passage and adoption.
