A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO EXECUTE A CONTRACT BETWEEN VIKTOR CONSTRUCTION CORP AND THE CITY OF HOLLYWOOD, FOR EXTERIOR PAINTING AT THE RADIUS PARKING GARAGE, IN THE AMOUNT OF \$70,700.00.

WHEREAS, the Department of Parking and Intergovernmental Affairs identified a need for the exterior painting of the Radius Parking Garage as part of routine maintenance; and

WHEREAS, the Department of Public Works staff prepared bid documents for the exterior work, and a Notice to Bidders for Project No. PK 13-019 was issued, on November 25, 2014 which included a Base Bid, a Deduct Alternate and two (2) Add Alternates; and

WHEREAS, the project was electronically advertised via BidSync in accordance with the City's Purchasing Ordinance, Section 38.42(A); and

WHEREAS, project specifications were viewed on line by fifty-seven (57) vendors and specifications were down loaded by eighteen (18) vendors; and

WHEREAS, through receipt of the City's bid specifications for this project, all prospective bidders were provided with a copy of the City's contract, including the terms and conditions contained therein; and

WHEREAS, bids were opened at 9 AM on Tuesday, December 16, 2014, which resulted in three (3) bids being received, reviewed and are listed below (see attached bid tabulation for complete list of bidders);

Tagarelli Construction, Inc. Tarpon Springs, FL	\$147,357.00
Viktor Construction Corp Tarpon Springs, FL	\$70,700.00
DSG Construction Hollywood, FL	\$189,000.00

WHEREAS, after review of the three (3) bids submitted and received, they were all deemed to be responsible and responsive; and

WHEREAS, staff has reviewed the bid submitted by Viktor Construction Corp and found it to be the lowest responsive and responsible in the amount of \$70,700.00; and

WHEREAS, the Director and Deputy Director of the Department of Public Works and the Director of Parking and Intergovernmental Affairs recommend the award of this contract to Viktor Construction Corp; and

WHEREAS, award is subject to the City's receipt and approval of all insurance certificates required by the City's Risk Manager, and indemnity/indemnification to the City; and

WHEREAS, the City may terminate the agreement should the Contractor fail to reasonably perform the services as specified or without cause, upon thirty (30) days written notification; and

WHEREAS, City staff checked the Viktor Construction Corp references for similar projects and they were satisfactory; and

WHEREAS, funding for this project is available in the Parking Enterprise Fund under account number 46.1100.14192.545.006301;

NOW THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:

Section 1: That it hereby approves and authorizes execution by the appropriate City Officials, of the attached contract between Viktor Construction Corp and the City of Hollywood, together with such non-material changes as may be subsequently agreed to by the City Manager and approved as to form and legality by the City Attorney.

AUTHORIZING EXECUTION OF THE ATTACHED CONTRACT WITH VIKTOR CONSTRUCTION CORP FOR EXTERIOR PAINTING AT THE RADIUS PARKING GARAGE
