

RESOLUTION NO. R-2013-090

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, AMENDING RESOLUTION NUMBERS R-2006-361, R-2006-433, R-2007-406, R-2008-202, R-2009-025, R-2009-189, R-2011-141 TO RESTRUCTURE THE COMPOSITION OF THE GREEN TEAM ADVISORY COMMITTEE TO ELIMINATE AND ADD POSITIONS.

WHEREAS, in an effort to simplify categories of membership relating to the Green Team Advisory Committee, the Director of Parking & Intergovernmental Affairs, as the committee liaison, recommends the committee membership be restructured; and

WHEREAS, the committee is currently comprised of eighteen (18) members, four (4) business members, one (1) environmental group member, one (1) non-profit member, one (1) college student member, one (1) local education committee member, one (1) South Florida Business Association member, and (9) citywide members; and

WHEREAS, the new composition is proposed to include: five (5) members who are Hollywood business owners/operators, one (1) environmental group member, one (1) representative of the Builders Association, eleven (11) citywide representatives; and

WHEREAS, the one (1) non-profit member, one (1) college student and one (1) local education committee member positions shall be eliminated; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:

Section 1: That the position of one (1) non-profit member is hereby eliminated.

Section 2: That the position of one (1) local education committee member is hereby eliminated.


Section 3: That the position of one (1) college student member is eliminated.

Section 4: That the new composition includes five (5) Hollywood business owners/operators, one (1) environmental group representative, one (1) builders association representative, eleven (11) citywide representatives.

Section 5: That this resolution shall be in full force and effect immediately upon its passage and adoption.


