A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, APPROVING ADDITIONAL TERMS AND CONDITIONS FOR PURCHASE ORDER PFY-2601225 TO PANTROPIC POWER, INC. FOR THE REPAIR OF GENERATOR #2, INCLUDING ALL COMPONENTS, PARTS, LABOR, AND WARRANTY; AND AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO IMPLEMENT OR EXECUTE ANY AND ALL OTHER DOCUMENTS NECESSARY TO FACILITATE REPAIR OF GENERATOR #2.

WHEREAS, on February 4, 2026, the City Commission adopted Resolution No. R-206-043, approving the purchase order to Pantropic Power, Inc. ("Pantropic") for the repair of generator #2 including all components, parts, labor, and warranty; and

WHEREAS, Pantropic has requested additional terms and conditions to the standard terms and conditions of Purchase Order PFY-2601225; and

WHEREAS, the additional terms and conditions include provisions regarding the order of precedence of relevant documents, breaker repairs or replacement, testing conditions, special damages limitations, warranty amendments, and waiver of jury trial; and

WHEREAS, the Director of the Department of Public Utilities recommend that the City Commission approve the additional terms and conditions.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA.

Section 1: That the foregoing "WHEREAS" clauses are ratified and confirmed as being true and correct and are incorporated in this Resolution.

Section 2: That it approves and authorizes the additional terms and conditions for Purchase Order PFY-2601225, together with such non-material changes as may subsequently be agreed to by the City Manager and approved as to form and legal sufficiency by the City Attorney.

Section 3: That it authorizes the appropriate City officials to implement or execute any and all documents necessary to facilitate the repair of generator #2, together with such non-material changes as may subsequently be agreed to by the City Manager and approved as to form and legal sufficiency by the City Attorney.
