A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, APPROVING AND AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO EXECUTE AMENDMENT NO. 22 TO THE LANDSCAPE INCLUSIVE MEMORANDUM OF AGREEMENT WITH THE FLORIDA DEPARTMENT OF TRANSPORTATION TO MAINTAIN THE LANDSCAPE IMPROVEMENTS WITHIN STATE ROAD 9 / I-95 RIGHTS-OF-WAY LOCATED AT THE STATE ROAD 820 (HOLLYWOOD BOULEVARD), STATE ROAD 822 (SHERIDAN STREET), AND STATE ROAD 848 (STIRLING ROAD) INTERCHANGES.

WHEREAS, on February 26, 2013, the City Commission passed and adopted Resolution No. R-2013-027 which authorized the execution of an Agreement with the Florida Department of Transportation ("FDOT"), and requires the City to maintain landscape and streetscape improvements within FDOT's medians, outside the travel way and made to the travel way, if applicable, that were made at the request of the City; and

WHEREAS, the Agreement has previously been amended several times to reflect physical changes to include new areas and locations, and revise responsibilities and obligations associated with the Agreement; and

WHEREAS, the City desires to enter into Amendment No. 22 to the Inclusive Landscape Maintenance Memorandum of Agreement ("Agreement") setting forth the associated responsibilities and obligations; and

WHEREAS, as State Road 9 / I-95 is within the jurisdictional roadways system of the State, FDOT requires Amendment No. 22 to the existing Agreement for inclusion of the landscape, irrigation, and site furnishing improvements by owner.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:

Section 1: That the foregoing "WHEREAS" clauses are ratified and confirmed as being true and correct and are incorporated in this Resolution.

Section 2: That it approves and authorizes the execution, by the appropriate City officials, of Amendment No. 22 to the Agreement with FDOT, together with such non-material changes as may be subsequently agreed to by the City Manager and approved as to form and legal sufficiency by the City Attorney.
