A RESOLUTION OF THE CITY COMMISSION OF THE
CITY OF HOLLYWOOD, FLORIDA, APPOINTING SIX

WHEREAS, Suzanne Cutrone currently serves as an At-large Member and her term expires on June 30, 2023; and

WHEREAS, Mary Jo O'Hara resigned and served as an At-large Member and her term expires on June 30, 2025; and

WHEREAS, the City Clerk provided notice to the public that positions were available and solicited interest forms from citizens to fill available vacancies; and
