

CITY OF HOLLYWOOD NOTICE OF HEARING TO REIMPOSE AND PROVIDE FOR COLLECTION OF FIRE RESCUE SPECIAL ASSESSMENTS



Notice is hereby given that the City Commission of the City of Hollywood will conduct a public hearing to consider reimposing fire rescue special assessments for the provision of fire rescue services within the City of Hollywood for the Fiscal Year beginning October 1, 2023.

The hearing will be held at 6:00 p.m. on September 14, 2023, in the City Commission Chamber, Room 219, 2600 Hollywood Boulevard, Hollywood, Florida, for the purpose of receiving public comment on the proposed assessments. All affected property owners have a right to appear at the hearing and to file written objections with the City Commission within 20 days of this notice. If a person decides to appeal any decision made by the City Commission with respect to any matter considered at the hearing, such person will need a record of the proceedings and may need to ensure that a verbatim record is made, including the testimony and evidence upon which the appeal is to be made. In accordance with the Americans with Disabilities Act, persons needing a special accommodation or an interpreter to participate in this proceeding should contact the Division of Engineering/Transportation & Mobility, Azita Behmardi, ADA Coordinator/City Engineer at 954-921-3251 (voice), abehmardi@hollywoodfl.org (email), or 800-955-8771 (V-TDD) at least five business days prior to the date of the hearing.

The assessment for each parcel of property will be based upon each parcel's classification and the total number of billing units attributed to that parcel. The following table reflects the proposed fire rescue assessment schedule.
