

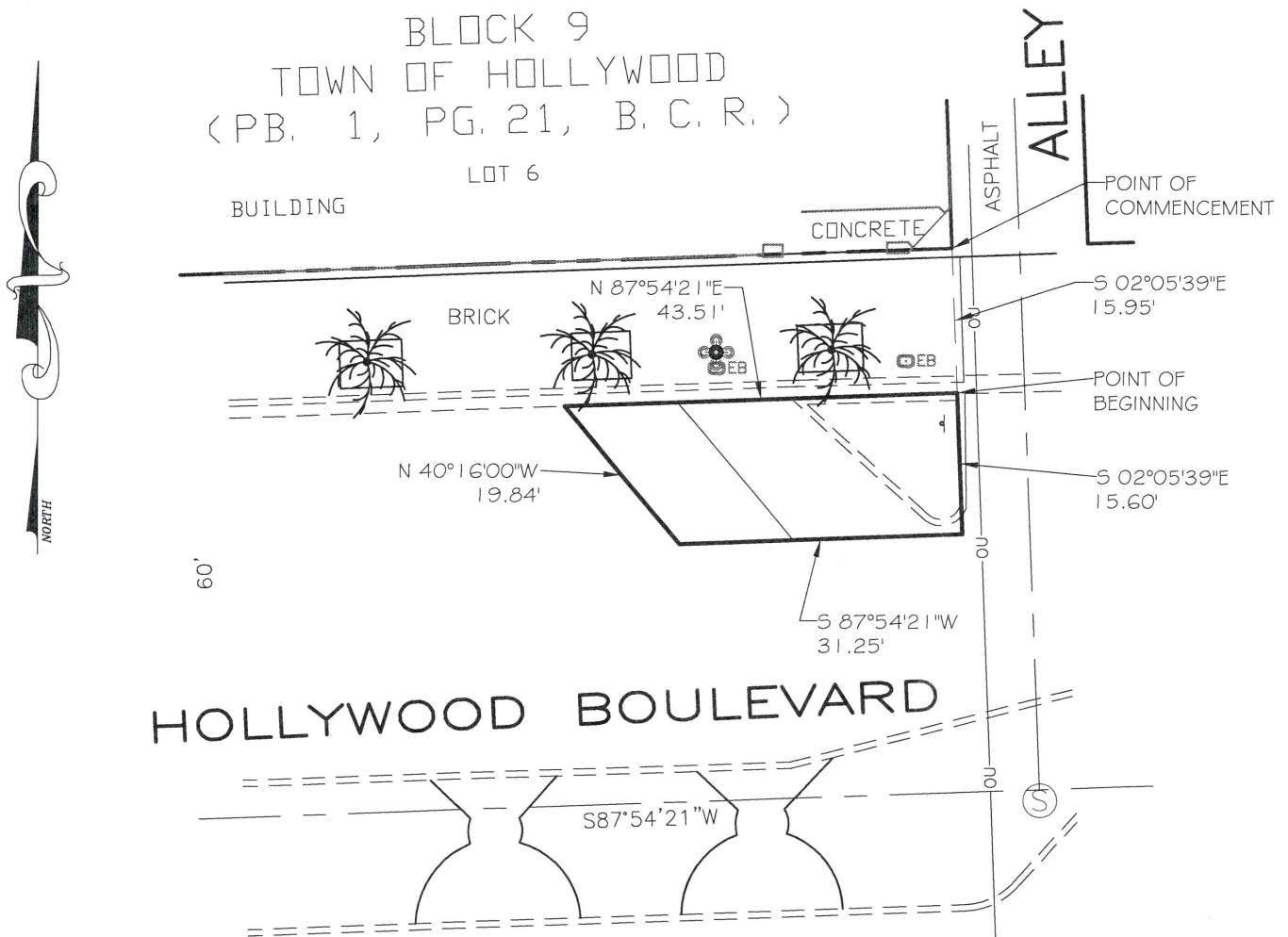
# DESCRIPTION:

THAT PORTION OF ASPHALT PARKING IN THE PUBLIC RIGHT-OF-WAY LYING SOUTHERLY OF 2035 HOLLYWOOD BLVD, BEING SOUTH OF LOT 6 OF BLOCK 9, "HOLLYWOOD", ACCORDING TO THE PLAT THERE OF, AS RECORDED IN PLAT BOOK 1, PAGE 24, OF THE PUBLIC RECORDS OF BROWARD COUNTY, FLORIDA,

## DESCRIBED AS FOLLOWS:

COMMENCE AT THE SOUTHEAST CORNER OF LOT 6, BLOCK 9 OF SAID " HOLLYWOOD" PLAT, BEING A POINT ON THE NORTH RIGHT-OF-WAY LINE OF HOLLYWOOD BOULEVARD AND WEST RIGHT-OF-WAY LINE OF THE ALLEY, THENCE SOUTH 02°05'39" EAST FROM SAID POINT ALONG THE SOUTHERLY EXTENSION OF EAST LINE OF SAID LOT 6 A DISTANCE OF 15.95 FEET, TO THE POINT OF BEGINNING;  
 THENCE CONTINUE SOUTH 02°05'39" EAST , A DISTANCE OF 15.60 FEET;  
 THENCE SOUTH 87°54'21"WEST, A DISTANCE OF 31.25 FEET;  
 THENCE NORTH 40°16'00"WEST, A DISTANCE OF 19.84 FEET;  
 THENCE NORTH 87°54'21"EAST, A DISTANCE OF 43.51 FEET TO THE POINT OF BEGINNING.

SAID LAND SITUATED IN THE CITY OF HOLLYWOOD, BROWARD COUNTY, FLORIDA. AND CONTAINING 583.0 SQUARE FEET, MORE OR LESS.


