A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, AUTHORIZING THE TERMINATION FOR CONVENIENCE OF THE AGREEMENT WITH REGIONS SECURITY SERVICES, INC. FOR UNIFORMED, ARMED AND UNARMED SECURITY GUARD SERVICES.

WHEREAS, Bid Number F-4551-17-PB was created and posted in BidSync on March 23, 2017, for Armed and Unarmed Security Services for an initial term of two years (November 1, 2017 through October 31, 2019), with three one year renewal options; and

WHEREAS, Regions Security Services, Inc. ("Regions") was issued a Blanket Purchase Agreement to provide Armed and Unarmed Security Guard Services at City Hall, the Waste Water Treatment Plant, the City's Parking Garages and the Marina; and

WHEREAS, City stakeholders have expressed shortcomings with the security services provided by Regions during the initial term starting November 1, 2017; and

WHEREAS, it is the recommendation of City stakeholders who have an interest in security services that the contract with Regions be terminated for convenience; and

WHEREAS, the contract with Regions provides that the City may, at any time and in its sole discretion, with or without cause, terminate the contract by written notice to the contractor; and

WHEREAS, the Director of Procurement and Contract Compliance informed Regions on December 3, 2018, that the recommendation to terminate the contract for convenience will be brought to the City Commission on December 19, 2018; and

WHEREAS, staff recommends that Regions cease providing security services for the City at midnight on January 6, 2019; and

WHEREAS, Regions will submit final invoices for services rendered; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA
