

# IN RECOGNITION OF THE 75<sup>th</sup> ANNIVERSARY OF SUN CREDIT UNION

- WHEREAS,** SUN CREDIT UNION WAS FOUNDED AS HOLLYWOOD MUNICIPAL EMPLOYEES CREDIT UNION BY ELEVEN CITY OF HOLLYWOOD EMPLOYEES IN DECEMBER OF 1946 WITH INITIAL ASSETS OF \$55.00 AND, UPON THE ATTAINMENT OF THEIR 75<sup>TH</sup> ANNIVERSARY, HAS GROWN TO \$120 MILLION IN DEPOSITS; AND
- WHEREAS,** FOR MANY DECADES THE HOLLYWOOD MUNICIPAL EMPLOYEES CREDIT UNION EXCLUSIVELY SERVED CITY OF HOLLYWOOD EMPLOYEES. WHEN THE REAL ESTATE PROFESSIONALS CREDIT UNION REQUESTED AND WERE GRANTED THE OPPORTUNITY TO MERGE WITH THE HOLLYWOOD MUNICIPAL EMPLOYEES CREDIT UNION, THE NAME WAS CHANGED TO SUN CREDIT UNION; AND
- WHEREAS,** MIAMI SHORES VILLAGE EMPLOYEES FEDERAL CREDIT UNION SIMILARLY PETITIONED AND WERE GIVEN FEDERAL AND STATE APPROVAL TO MERGE INTO SUN CREDIT UNION; AND
- WHEREAS,** FURTHER INCREASES IN THE SCOPE OF MEMBERSHIP INCLUDED MEMBERS OF A NUMBER OF SOUTH BROWARD AND MIAMI-DADE COUNTY CHAMBERS OF COMMERCE; AND
- WHEREAS,** SUN (AN ACRONYM FOR SERVICE, UNITY, AND NEIGHBOR) CREDIT UNION HAS BEEN A PREEMINENT SUPPORTER OF THE CITY OF HOLLYWOOD, AFFILIATED CHAMBERS OF COMMERCE, AND LOCAL COMMUNITIES AND CHARITIES; AND
- WHEREAS,** SUN CREDIT UNION HAS ATTAINED ESTEEM AMONG THE CREDIT UNION COMMUNITY WITHIN THE SOUTHEASTERN UNITED STATES; NOW
- THEREFORE,** JOSH LEVY, MAYOR OF THE CITY OF HOLLYWOOD, FLORIDA, AND THE HOLLYWOOD CITY COMMISSION, HONORS SUN CREDIT UNION FOR THEIR 75 YEARS OF SIGNIFICANT CONTRIBUTIONS TO THE HOLLYWOOD COMMUNITY.
