A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD FLORIDA, AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO ISSUE A PURCHASE ORDER TO PYTHON MANUFACTURING LIMITED, D/B/A SUPERIOR ROADS SOLUTIONS, FOR THE PURCHASE OF A PYTHON 5000 ASPHALT POTHOLE PATCHING MACHINE IN THE AMOUNT OF \$458,180.44 IN ACCORDANCE WITH SECTION 38.41(C)(2) OF THE PROCUREMENT CODE (SOLE SOURCE).

WHEREAS, road repair is an integral part of the City's beatification and safety plan, and it would be beneficial for the Department of Public Works to acquire a Python 5000 Asphalt Pothole Patching Machine to keep up with the volume of potholes being reported daily and lessen the probability for dangerous traffic issues; and

WHEREAS, pursuant to Section 38.41(C)(2) of the Procurement Ordinance, sole-source goods, supplies, materials, equipment and services, such as unique, patented, or franchised goods, supplies, materials, equipment or services, are exempt from the requirements of the Purchasing Code if the Chief Procurement Officer determines, after conducting a good faith review of available sources, that the particular supply or service is available from only one source; and

WHEREAS, Python Manufacturing Limited, d/b/a Superior Roads Solutions, is the only company that manufactures the Python pothole patching machine, and unlike other self-propelled pothole patching machines, the Python can utilize either hot or cold mix, does not depend on a specific proprietary mix and is unique because it is the only machine that is equipped with a roller compactor that is controlled inside the cab; and

WHEREAS, it is the recommendation of the Public Works Director to approve the issuance of a Purchase Order in the amount of \$458,180.44 for the purchase of the Python 5000 Asphalt Pothole Patching Machine; and

WHEREAS, funding for the purchase of the pothole machine is available in account number 334.509901.51900.564530.001506.000.000.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY OF HOLLYWOOD, FLORIDA:
