Proposal for: The Villas of Positano – Light Pole Replacement

Pomeroy Electric Incorporated will furnish labor & misc. electrical materials to remove (19) existing light poles and install (21) new light poles and light fixture heads as per electrical drawing sheets E-001; E-012; E-101; E-102; E-502 & E-711 by OSBORN Engineering. Our intent is to work on multiple light poles within the daylight hours and ensuring these are energized before nightfall. Refer to scope below:

## **Included Scope:**

- 1. Disconnect, removal and disposal of existing concrete light pole and fixture head. The fixture heads will be turned over to the client for attic stock.
- 2. Rework existing underground electrical to allow for the new light pole installation.
- 3. Furnish and install new concrete bases; cast aluminum light poles and light fixture heads.
- 4. Furnish and install new pull boxes, ground rods and misc. electrical materials at the base of each light pole.
- 5. We've included (2) month rental of 19' scissor lift for the installation of the fixture heads.
- 6. The existing wiring, raceways and panels were found to be in good working order, therefore, these are to remain as is and use for the new installation.
- 7. All work is to be performed during regular working hours. (No night; OT or weekend work is included)

## Items Not Included:

- a) All or any items not listed above.
- b) Engineered drawings, wind load calculations, permits and permit fees.
- c) Overtime, shift work or accelerated schedule costs.
- d) Employee parking and all associated fees.
- e) Any items requested by the Authority Having Jurisdiction or existing code violations/upgrades.
