SECOND AMENDMENT TO AGREEMENT
BETWEEN

HEALTH SCREENING PHYSICALS FOR JFRD PERSONNEL

THIS SECOND AMENDMENT to Agreement is made and entered into in duplicate this 30 day of March, 2016, by and between the **CITY OF JACKSONVILLE**, a municipal corporation existing under the Constitution and the laws of the State of Florida (hereinafter the "CITY"), and **LIFE EXTENSION CLINICS, INC. d/b/a LIFE SCAN WELLNESS CENTERS**, a Florida corporation with principal office at 1011 North MacDill Avenue, Tampa, Florida 33607 (hereinafter the "PROVIDER"), for health screening physical examinations and immunizations for personnel and ancillary personnel of CITY's Fire and Rescue Department (hereinafter the "Project").

WITNESSETH:

WHEREAS, ON May 6, 2014, CITY and PROVIDER made and entered into City of Jacksonville Contract No. 8158-06 for the Project (hereinafter the "Agreement"); and

WHEREAS, said Agreement has been amended once previously; and

WHEREAS, said Agreement should be amended further by exercising the second of three one (1) year renewal options so as to extend the period of service from April 1, 2016, through March 31, 2017, with one (1) renewal option remaining at terms mutually agreeable, and by increasing the maximum indebtedness by \$100,000.00 to a new not-to-exceed total maximum indebtedness of \$300,000.00, with all other provisions, terms, and conditions remaining the same; now therefore

IN CONSIDERATION of the premises and of the mutual covenants and agreements hereinafter contained, the parties agree as follows:

1. The above-stated recitals are accurate, true, and correct and are incorporated herein and made a part hereof by this reference.

2. Section 3.01 of said Agreement is amended by exercising the second of three one (1) year renewal options so as to extend the period of service from April 1, 2016, through March 31, 2017, with one (1) renewal option remaining at terms mutually agreeable, and as amended shall read as follows:

“3.01. The term of this Agreement shall become effective as of the Effective Date and shall continue and remain in full force and effect as to all its terms, conditions, and provisions as set forth herein until March 31, 2017, unless sooner terminated by either party, with or without cause, by giving of not less than thirty (30) days’ prior written notice to the other party to this Agreement. This Agreement may be renewed in the sole discretion of the CITY for one (1) additional one (1) year period upon terms and conditions mutually agreeable to the parties.”

3. Section 7.01.02 of said Agreement is amended by increasing the maximum indebtedness by \$100,000.00 to a new not-to-exceed total maximum indebtedness of \$300,000.00, and as amended shall read as follows:


“7.01.02. The maximum indebtedness of the CITY for all fees, reimbursable items, or other costs for actual Services provided by PROVIDER pursuant to this Agreement shall not exceed the sum of THREE HUNDRED THOUSAND AND 00/100 DOLLARS (\$300,000.00) for the term of this Agreement.”

SAVE AND EXCEPT as expressly amended herein, the provisions, terms, and conditions of said Agreement, as previously amended, shall remain unchanged and shall continue in full force and effect.

RESOLUTION NO. R-2015-370

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO ISSUE THE ATTACHED BLANKET PURCHASE ORDER AGREEMENT BETWEEN LIFE EXTENSION CLINICS, INC. D/B/A LIFE SCAN WELLNESS CENTERS AND THE CITY OF HOLLYWOOD TO PROVIDE ANNUAL HEALTH SCREENING PHYSICALS FOR FIRE RESCUE & BEACH SAFETY AND ANCILLARY PERSONNEL IN AN ESTIMATED ANNUAL AMOUNT OF \$75,000.00.

WHEREAS, the Department of Human Resources requires an agreement with a qualified vendor to provide health screening services including a comprehensive medical physical/examination for eligible Fire Rescue & Beach Safety personnel in order to provide the City's contractually negotiated annual medical examination benefit paid for by the City; and

WHEREAS, in addition, the Department of Human Resources will make available the health screening services including a comprehensive medical physical/examination to ancillary City personnel with all costs to be borne by the employee and at no cost to the City; and

WHEREAS, the Department of Human Resources staff researched and reviewed medical health screening physical services available and selected Life Extension Clinic, Inc. d/b/a Life Scan Wellness Centers who has offered the required services available on the City of Jacksonville, Florida Contract No. P-41-13; and

WHEREAS, Section 38.40(C)(5) of the Purchasing Ordinance allows the Director to procure, without following formal procedures, all goods and services which are subject of contracts with the state, its political subdivisions, the United States government, other governmental entities, or a corporation not for profit whose members are governmental entities, public officers, or any combination thereof, provided however, the goods and services are: (i) the subject of a price schedule negotiated by the state or the United States government, or (ii) the subject of a contract with another governmental entity or a corporation not for profit whose members are governmental entities, public officers, or any combination thereof, which contract is based strictly on competitive bids or competitive proposals and not on any preference; and

WHEREAS, health screening services including comprehensive medical physical/examinations for eligible Fire & Rescue Department Personnel/Ancillary Personnel was competitively solicited by the City of Jacksonville, Florida via the issuance, processing and award of RFP #P-41-13; and

WHEREAS, on August 25, 2014, the City of Jacksonville, Florida awarded RFP #P-41-13 to Life Extension Clinic, Inc. d/b/a Life Scan Wellness Centers located in Tampa, Florida to provide health screening physicals for an initial contract period of six (6) months from October 1, 2014 through March 31, 2015 with the option to renew for three (3) additional one (1) year periods, under the mutually agreed upon terms and conditions and RFP #P-41-13; and

WHEREAS, on May 18, 2015, the City of Jacksonville, Florida renewed the agreement with Life Extension Clinic, Inc. d/b/a Life Scan Wellness Centers to provide health screening physicals for the contract's initial one (1) year renewal period from April 1, 2015 through March 31, 2016 with the option to renew for two (2) additional one (1) year periods, under the mutually agreed upon terms and conditions and RFP #P-41-13; and

WHEREAS, the Director of Human Resources and the Director of Procurement Services have recommended that the City Commission approve the execution of the attached blanket purchase order for an initial period expiring on March 31, 2016 with the option to renew for two (2) additional one (1) year periods for health screening services, for an estimated annual expenditure of \$75,000.00; and

WHEREAS, award is subject to the City's receipt and approval of all insurance certificates required by the City's Risk Manager, along with signed statements of Hold Harmless and Indemnity to the City; and

WHEREAS, funding for this agreement has been provided in the FY16 Health Claims Reserves budget account number 58.1241.00000.590.009199 and will be budgeted in subsequent fiscal years;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:

Section 1: That it hereby approves and authorizes the issuance, by the appropriate City Officials, of the attached blanket purchase order between Life Extension Clinic, Inc. d/b/a Life Scan Wellness Centers and the City of Hollywood, together with such non-material changes as may be subsequently agreed to by the City Manager and approved as to form and legality by the City Attorney.
