A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, REPEALING THE LIST OF CHARITIES AND FUNDRAISING EVENTS FORMALLY APPROVED BY RESOLUTION NOS. R-2017-293 AND R-2018-278, AND APPROVING THE LIST OF CHARITIES FOR THE SOLICITATION OF FUNDS PURSUANT TO BROWARD COUNTY'S CODE OF ETHICS FOR ELECTED OFFICIALS.

WHEREAS, on October 4, 2017, the City Commission adopted Resolution No. R-2017-293, formally approving charities and fundraising events for the solicitation of funds pursuant to the County's Code of Ethics for Elected Officials ("Code of Ethics"); and

WHEREAS, on September 5, 2018, the City Commission adopted Resolution No. R-2018-278, amending the list of charitable organizations; and

WHEREAS, the City Commission desires to repeal the list of approved Charities adopted through Resolutions R-2017-293 and R-2018-278, and approve the list of Charities attached to this Resolution as Exhibit "A"; and

WHEREAS, to be approved for the solicitation of funds pursuant to the Code of Ethics, an organization must qualify as a charity under the Internal Revenue Code.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:

Section 1: That the foregoing "WHEREAS" clauses are ratified and confirmed as being true and correct and incorporated in this Resolution.

Section 2: That it repeals Resolutions R-2017-293 and R-2018-278, including the list of formally approved Charities attached to those Resolutions, and approves the list of formally approved charities for the solicitation of funds pursuant to the Broward County Code of Ethics attached as Exhibit "A," subject to the requirement that to be approved for the solicitation of funds pursuant to the Code of Ethics, each entity must qualify as a charity under the rules of the Internal Revenue Code.
