## The Florida Recreation Development Assistance Program (FRDAP)

The FRDAP program leverages local investment in recreation development with state dollars to maximize the provision of vital recreational opportunities.

The program funds development of greenways and trails, playgrounds, ball fields, passive recreation amenities, and other items that make Florida's communities attractive places for citizens and visitors to affordably enjoy the State's natural resources.

FRDAP is a public partnership that:

Allows the public to enjoy and safely access public parks and environmental lands, connecting with nature and the out-of-doors;

Provides a high return on the investment in parks and environmental lands by providing a natural framework that protects our

## Full Funding of Florida Forever is a Must

Florida's legacy land acquisition and development program, Florida Forever, has not been fully funded in several years. As a result, we are losing ground in our efforts to assure we preserve and protect conservation lands for future generations of Floridians. Florida Forever, which was authorized to spend \$300 million a year, was interrupted because of declines in state revenues and shifts in priorities related to the economic recovery. With the economy recovering, it is time again to invest in the highest priority conservation lands. The FY 2014 state budget provides an opportunity to invest in public lands, as the Preservation 2000 bonds will be paid off, freeing more than \$250 million in recurring state revenue.

- Park development stimulates local economies by employing professional services and local contractors;
- Land acquisition programs allow for the strategic purchase of open space to provide for recreation, and the protection of critical water resources for future generations;

Historical and cultural heritage sites require preservation and restoration assistance;

The ability to leverage local, state and federal funding mechanisms that provide for open space and clean water, assures ample protection exists for wildlife to prosper and regenerate.

#### **2014 Legislative Priorities**

It's not just teaching a game. It's COACHING for life...Florida's parks encourage healthy, active lifestyles as well as social development. Sound bodies and sound minds require physical activity and the chance to experience personal growth. Parks offer a wide range of activities suitable for all ages to get outdoors and get active – teaching positive lifestyle habits in all areas from nutrition to physical activities to sports and life skills.

### Youth and Public Safety

During the time children are attending school, they are afforded more protection through Florida statute than when they attend local government parks and recreation programs which provide supervised care during non-school hours. We support any effort that will:

A Increase measures to protect youth from exposure to sexual predators and offenders, including their access to areas where children congregate, and identification through background screening;

Establish funding for the fingerprinting and background screening of all volunteers and employees who work with youth;
Establish a statewide clearinghouse of individuals who have cleared screening and fingerprint checks, to avoid duplicating these checks and increasing the costs of protecting youth in our communities, and the cost of providing quality youth programs;

Provide boundaries for drugs, alcohol, tobacco products and weapons in areas where children are regularly present in organized programs such as schools, parks, libraries, sports fields and facilities.

facilities for physical activity. They also provide programs allowing citizens to maintain a network within their community that fosters a healthy state of mind and a connection to community resources.

Nearly 300 children ages 6 to 14 enrolled in the Miami-Dade County Parks Fit2Play Program (with the University of Miami) maintained healthy weight and body mass index (BMI) throughout the school year. As a result of participation in the Fit2Play Program, those who started the program with high blood pressure, were able to lower their pressure. The school children also improved their physical health, fitness levels and knowledge about nutrition and healthy lifestyle behaviors.
