A RESOLUTION OF THE CITY OF HOLLYWOOD, FLORIDA, AMENDING THE FISCAL YEAR 2016 ADOPTED OPERATING BUDGET (R-2015-294) AND CAPITAL IMPROVEMENT PROGRAM (R-2015-295), AS AMENDED AND AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO EXECUTE THE ATTACHED CONTRACT BETWEEN SUN UP ENTERPRISES AND THE CITY OF HOLLYWOOD, FOR THE TRAFFIC CIRCLE AT NORTH 13TH AVENUE AND TYLER STREET (PROJECT BID NUMBER PW-15-034), IN THE AMOUNT OF \$135,919.80; AND REVISING OPERATING REVENUES, AUTHORIZING BUDGETARY TRANSFERS, REAUTHORIZING AND RE-APPROPRIATING CERTAIN FUNDING, AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, construction of a traffic circle at North 13th Avenue and Tyler Street is one of the safety improvements to mitigate impacts of the 2010 Florida Department of Transportation access management and implementation of landscaped and safety medians project; and

WHEREAS, specifications for the construction of the traffic circle at North 13th Avenue and Tyler Street were prepared by the Engineering and Architectural Services Division of the Department of Public Works; and

WHEREAS, the Traffic Circle at North 13th Avenue and Tyler Street (Project Bid Number PW-15-034), was electronically advertised via BidSync on December 9, 2015, a Pre-Bid Meeting was held on December 17, 2015, and the construction documents and specifications were viewed by forty-six (46) vendors with eight (8) vendors downloading the Project Manual and specifications; and

WHEREAS, through receipt of the City's bid specifications for this project, all prospective bidders were provided with a copy of the City's contract, including the terms and conditions contained therein; and

WHEREAS, three (3) bids were received and publicly opened on December 23, 2015, with the bid responses as follows:

WHEREAS, staff has reviewed all submitted bids and determined the bid received from Sun Up Enterprises was the lowest, responsive and responsible bid, and therefore, recommends the award of this contract to Sun Up Enterprises in the amount of \$135,919.80; and

WHEREAS, award is subject to the City's receipt and approval of all insurance certificates and bonds required by the City's Risk Manager, and indemnification to the City; and

WHEREAS, it is necessary to amend the approved FY2016 Capital Improvements Program and allocate funding in the amount \$150,000.00 for the Traffic Circle At North 13th Avenue And Tyler Street Project as set forth in Exhibit 1, attached;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION
THE CITY OF HOLLYWOOD, FLORIDA:

Section 1: That it hereby approves and authorizes the execution by the appropriate City Officials, of the attached contract between Sun Up Enterprises and the City of Hollywood, together with such non-material changes, as may be subsequently agreed to by the City Manager and approved as to form and legality by the City Attorney.

Section 2: That it hereby approves an amendment to the approved FY 2016 Operating Budget and the FY 2016 Capital Improvement Program, as set forth in the attached Exhibit 1.

Section 3: That the Department of Financial Services is hereby authorized to establish such line item accounts as may be necessary to properly monitor and track expenditures.
