A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, APPROVING AND AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO EXECUTE AN AUTHORIZATION TO PROCEED WITH THE CORRADINO GROUP, INC. FOR PROFESSIONAL CONSULTING SERVICES FOR THE PREPARATION OF THE FINAL DESIGN, PERMITTING, AND CONSTRUCTION SPECIFICATIONS FOR THE REPLACEMENT AND WIDENING OF THE JOHNSON STREET BRIDGE FOR A TOTAL AMOUNT NOT TO EXCEED \$589,008.78.

WHEREAS, on September 1, 2021, the City Commission passed and adopted Resolution No. R-2021-208, which approved and authorized appropriate City officials to execute continuing services agreements with the highest-ranked firms based upon 10 disciplines to provide engineering services for Citywide projects, one of the firms being the Corradino Group, Inc. ("CG"); and

WHEREAS, on February 21, 2023, the Department of Development Services, Engineering, Transportation and Mobility Division issued an Authorization to Proceed (ATP-01) in the amount of \$33,899.30 to CG for a feasibility study and conceptual design to widen the Johnson Street Bridge located between North 30th Road and North 31st Avenue; and

WHEREAS, the results of the feasibility study indicated that due to the limited design life of the existing structures, a complete replacement of the bridge was necessary in order to widen the bridge; and

WHEREAS, the Department of Development Services, Engineering, Transportation and Mobility Division staff negotiated a proposal with CG to provide professional consulting services for the final design, permitting, and construction specifications for the replacement and widening of the existing Johnson Street bridge located between North 30th Road and North 31st Avenue in an amount not to exceed \$589,008.78; and

WHEREAS, staff evaluated the proposal inclusive of the scope and fee and determined that the negotiated fee is fair and reasonable and in accordance with industry standards; and

WHEREAS, the Interim Director of Development Services and the Director of Procurement and Contract Compliance recommend that the City Commission authorize the appropriate City officials to execute the attached Authorization To Proceed (ATP 02) with CG based upon its proposal and the terms and conditions of the Professional Engineering Continuing Services Agreement for Civil Engineering and Roadway Design Services; and

WHEREAS, funding for this project was included in the amended FY 2024 Capital Improvement Plan and is available in account number 334.149901.54100.563010.001687.000.000.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA.

Section 1: That the foregoing "WHEREAS" clauses are ratified and confirmed as being true and correct and are incorporated in this Resolution.

Section 2: That it approves and authorizes the execution, by the appropriate City officials, of the attached Authorization to Proceed with The Corradino Group, Inc., together with such non-material changes as may be subsequently agreed to by the City Manager and approved as to form by the City Attorney.

Section 3: That this Resolution shall be in full force and effect immediately upon its passage and adoption.
