# AGREEMENT BETWEEN CITY OF HOLLYWOOD, FLORIDA AND ICON ENTERPRISES, INC. D/B/A CIVICPLUS FOR WEBSITE REDESIGN

This Agreement made and entered into this <u>29</u> day of <u>Sept</u>, 2011, by and between the CITY OF HOLLYWOOD, FLORIDA, a municipal corporation of the State of Florida (hereinafter "City") and Icon Enterprises, Inc. d/b/a CivicPlus (hereinafter "Vendor").

WHEREAS, the City of Naples, Florida issued Request for Proposal No. 033-11 (hereinafter the "RFP") for the restructuring and redesign of the City's website; and

WHEREAS, Vendor submitted a proposal in response to the RFP;

WHEREAS, City staff has determined that the City's website should be restructured and redesigned and the City of Naples RFP and Vendor's response meets all necessary requirements in order to complete this project; and

WHEREAS, pursuant to Resolution No. <u>R-2011-239</u>, the City Commission approved the execution of this Agreement and the Software License Agreement with Vendor;

NOW, THEREFORE, in consideration of the mutual promises and understandings set forth herein, the parties hereto agree as follows:

# ARTICLE I INCORPORATION OF DOCUMENTS

The RFP, including any addenda thereto, the proposal submitted by Vendor, and the Purchase Order, if applicable, and the Software License Agreement (hereinafter, collectively, the "RFP Documents") are attached hereto and incorporated herein in their entirety. Except as otherwise provided in this Agreement, the parties shall comply with the terms and conditions set forth in the RFP Documents. In the event of conflict, the terms of the RFP shall prevail.

# ARTICLE II COMPENSATION

The total amount to be paid by the CITY under this Agreement for all services as outlined in the RFP documents shall not exceed a total contract amount of Twenty-Nine Thousand Six Hundred and Eight Dollars (\$29,608.00) in accordance with Service & License Agreement. Vendor shall provide the First Year's Annual Support, Maintenance, and Hosting for free. The

City has the option to retain maintenance services beyond the First Year in accordance with the payment schedule set for in the Service & License Agreement. Said exercise of such option is contingent upon an annual appropriation of said fees approved by the City Commission. Upon the maintenance services being retained, such agreement will be reduced to writing.

# ARTICLE III DISCLOSURE AND OWNERSHIP OF DOCUMENTS

In addition to the provisions set forth in the RFP Documents, Vendor agrees to the following:

- 3.1 Any and all art, concepts, work, reports, photographs, video, surveys and other data and documents provided or created in connection with this Agreement and services provided by Vendor are and shall remain the property of the City upon payment in full to Vendor by the City. In the event of termination of this Agreement, any reports, photographs, surveys, and other data and documents prepared by Vendor, whether finished or unfinished, shall become the property of the City and shall be delivered by Vendor within seven (7) days from the date of termination of this Agreement and the Services & Licensing Agreement by either party.
- 3.2 All rights of logo design and logo artwork that Vendor has designed or created for the City belong solely to the City upon payment in full to Vendor by the City. Vendor does not hold any rights to the logo-design created for the City.
- 3.2 Vendor warrants that its designs are of its own creation and are not copied from or inspired by existing designs or trademarks but does not warrant that a design similar to that which was created by Vendor, but which Vendor was not aware of at the time of the creation of its design, does not exist. If for any reason a logo, graphic, web element, or advertisement, designed by Vendor infringes upon another party's logo, slogan or tagline, Vendor will provide a free redraw session with a new set of logos, advertisements, web element, slogan or taglines.
- 3.3 City retains the right to use new logo designs in all media useful for City promotion upon payment in full to Vendor by City.
- 3.4 Vendor hereby acknowledges and warrants that all logo designs are original and that Vendor owns the rights, the ability to confer such rights and such rights granted do not conflict with any other agreements Vendor may have.
- 3.5 All covenants, agreements, representations and warranties made herein, or otherwise made in writing by any party pursuant hereto, including but not limited to any representations made herein relating to disclosure or ownership of documents, shall survive the execution and delivery of this Agreement and the consummation of the transactions contemplated hereby.

# ARTICLE IV REMEDIES

This Agreement shall be governed by the laws of the State of Florida. Any and all legal action necessary to enforce this Agreement will be held in Broward County, Florida. No remedy herein conferred upon any party is intended to be exclusive of any other remedy, and each and every such remedy shall be cumulative and in addition to every other remedy given hereunder or now or hereafter existing at law or in equity or by statute or otherwise. No single or partial exercise by any party of any right, power or remedy hereunder shall preclude any other or further exercise hereof.

## ARTICLE V SEVERABILITY

If any term or provision of this Agreement, or the application thereof to any person or circumstances shall, to any extent, be held invalid or unenforceable, the remainder of this Agreement, or the application of such term or provision to persons or circumstances other than those as to which it is held invalid or unenforceable, shall not be affected, and every other term and provision of this Agreement shall be deemed valid and enforceable to the extent permitted by law.

#### ARTICLE VI ENTIRETY OF CONTRACTUAL AGREEMENT

This Agreement, together with the attachments hereto, sets forth the entire Agreement between the parties, and there are no promises or understandings other than those stated herein. None of the provisions, terms or conditions contained in this Agreement may be added to, modified, superseded or otherwise altered, except by written instrument executed by the parties hereto.

## ARTICLE VII NOTICE

All notices required shall be sent by certified mail, return receipt requested. If sent to City, such notices shall be mailed to:

Nothing in this Agreement shall be construed to give any rights or benefits to anyone other than City and Vendor.



#### Force Majeure

35. No party shall have any liability to the other hereunder by reason of any delay or failure to perform any obligation or covenant if the delay or failure to perform is occasioned by force majeure, meaning any act of God, storm, fire, casualty, unanticipated work stoppage, strike, lockout, labor dispute, civic disturbance, riot, war, national emergency, act of Government, act of public enemy, or other cause of similar or dissimilar nature beyond its control.
