14	WHEREAS, Law Enforcement Officers are often the last resort when responding
15	to an issue involving stray animals or animal endangerment; and
16	WHEREAS, in the past, such animals could be immediately turned over to the
17	Broward County Animal Care and Adoption Division; and
18	WHEREAS, the Broward County Animal Care and Adoption Division unilaterally
19	changed the intake policy to require municipalities including law enforcement and good
20	Samaritan residents to hold animals for 72 hours before being taken in by the County;

22	WHEREAS, most municipalities in Broward County do not have the resources or
23	capacity to hold and care for animals properly without diverting resources meant to
24	provide safety for residents; and

26	WHEREAS, the Mayor and City Commission believe that urging the Broward
27	County Animal Care and Adoption Division to abandon the 72-hour-hold requirement and
28	accept animals immediately is in the best interests of the residents and animals of the
29	City.
