Re: Community Meeting for Rezoning, Site Plan and Design Approval for "Soleste La Piazza"

Dear Ms. Watson,

On behalf of The Estate Companies ("Developer"), please accept this summary of the community meeting regarding the proposed residential and commercial development proposed for the La Piazza property on Hollywood Circle. In conjunction with the CRA, we held the community meeting regarding this project on May 4, 2023.

Attached hereto as Attachment 1 is the notice which was sent regarding this community meeting. Attached hereto as Attachment 2 is the list of organizations and property owners invited to attend the May 4th community meeting, as well as the certification regarding the invitees. Attached hereto as Attachment 3 is the presentation made by the Applicant and its representatives. Attachment 4 is a list of those who attended the meeting.

The CRA Director, Jorge Camejo made a brief presentation explaining that the rezoning from GU to YC was necessary since the CRA Board had approved the sale of the subject property to a private party, Developer, the GU zoning was no longer appropriate. Mr. Camejo further explained how the current level of development on the subject property was an underutilization of this sector of Young Circle and that the proposed redevelopment was more consistent with the CRA Redevelopment Plan and permitted by the Downtown Regional Activity Center. The developer then presented the enclosed presentation. The attendees raised a number of questions/comments regarding the project. Below is a list of questions/comments raised and responses provided:

1. An existing resident of La Piazza asked how existing tenants would be handled?

The Developer explained that tenants would be provide ample time to relocate and noted that a number of new developments, including those by The Estate Companies, would be available for tenants to relocate.

2. An attendee noted that given the level of vacant commercial space in downtown Hollywood, how did they intend to get occupancy for more commercial use?

Developer explained that given the number of new and approved residential developments in the downtown, there would be a growing need for more local commercial use.

3. An attendee asked if we would revisit some design elements on the exterior or the building, particularly the treatment on the garage facades and incorporation of roof level decorative lighting.

In response, Developer is considering some modifications to those facades, will be incorporating roof level decorative lighting.

4. There was a request for additional information regarding how the project addresses "sustainable development".

Developer noted that the project will meet all City and Florida Building Code sustainability requirements and contribute to the City's creation of a vibrant downtown where people can live, work and play.

The general sentiment at the meeting was support for the project and what it meant to implementing the City's long-term vision for the downtown and Hollywood Circle.

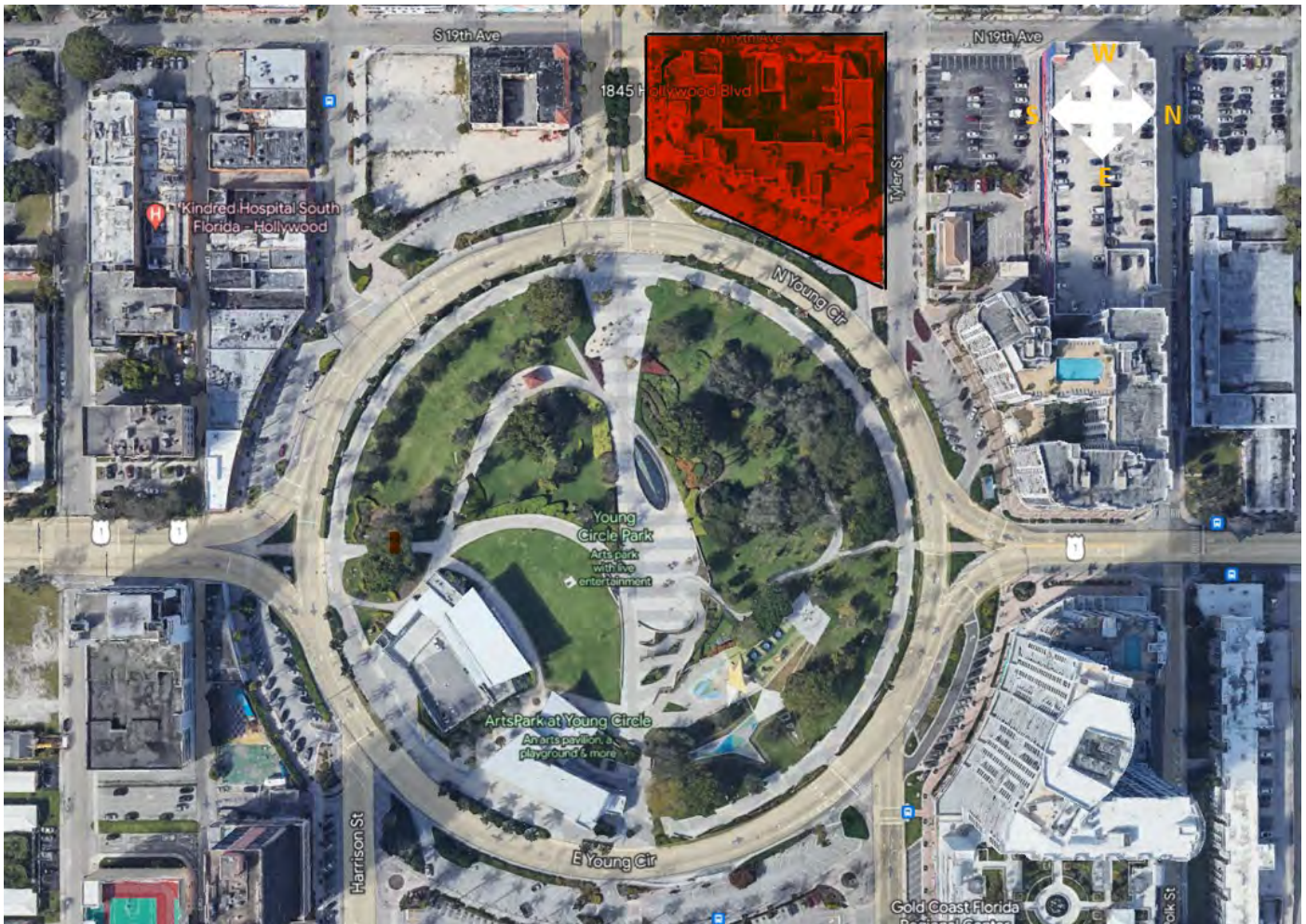

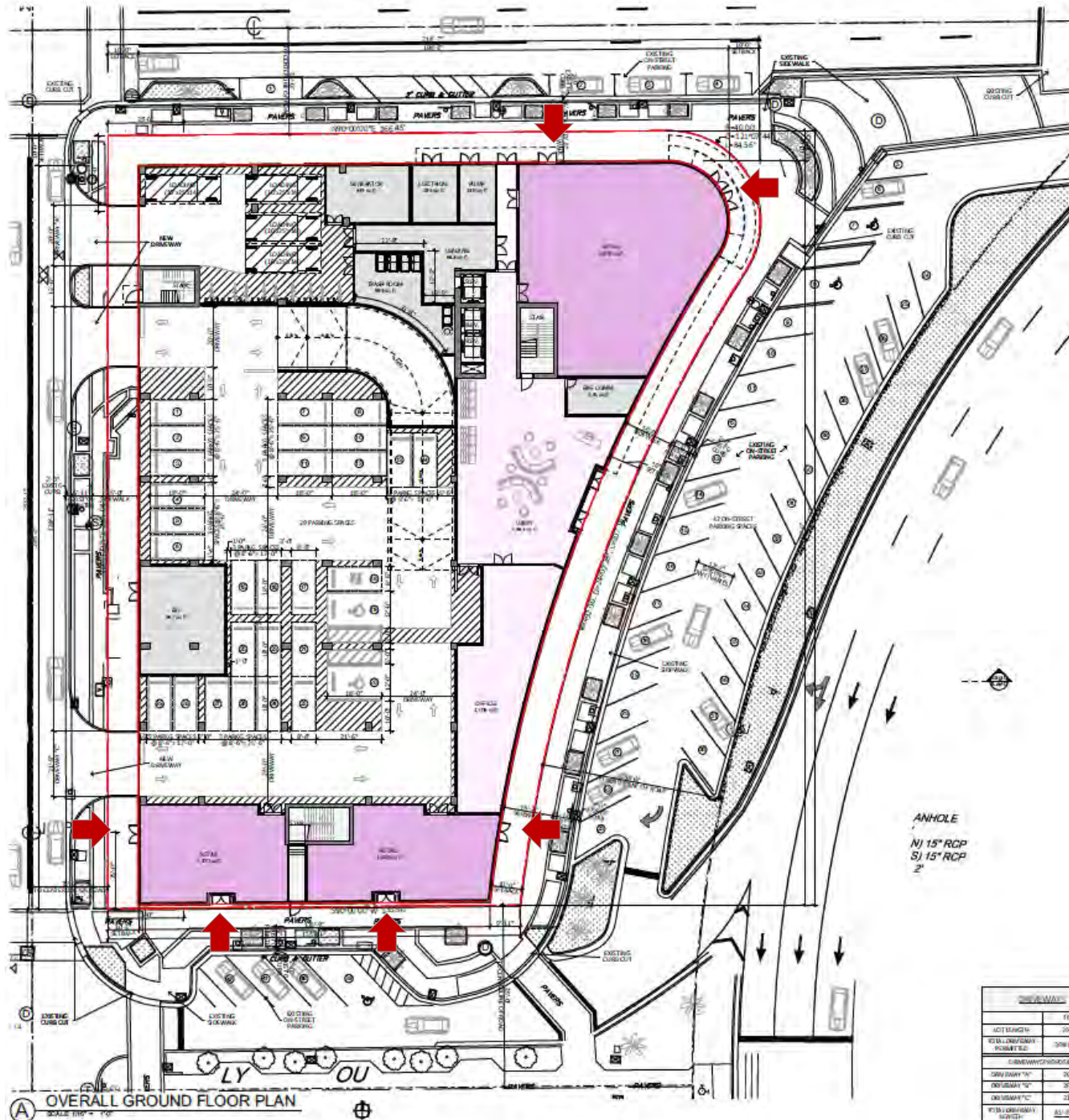

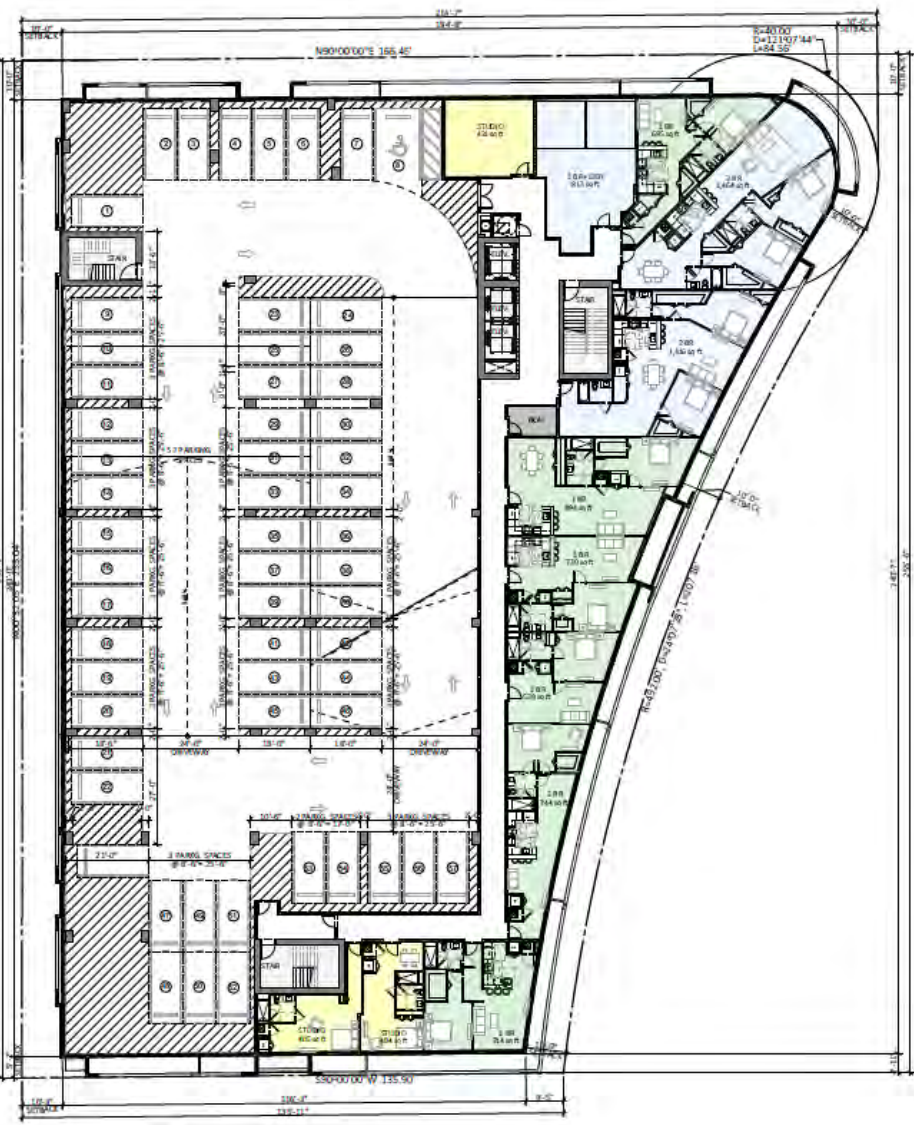

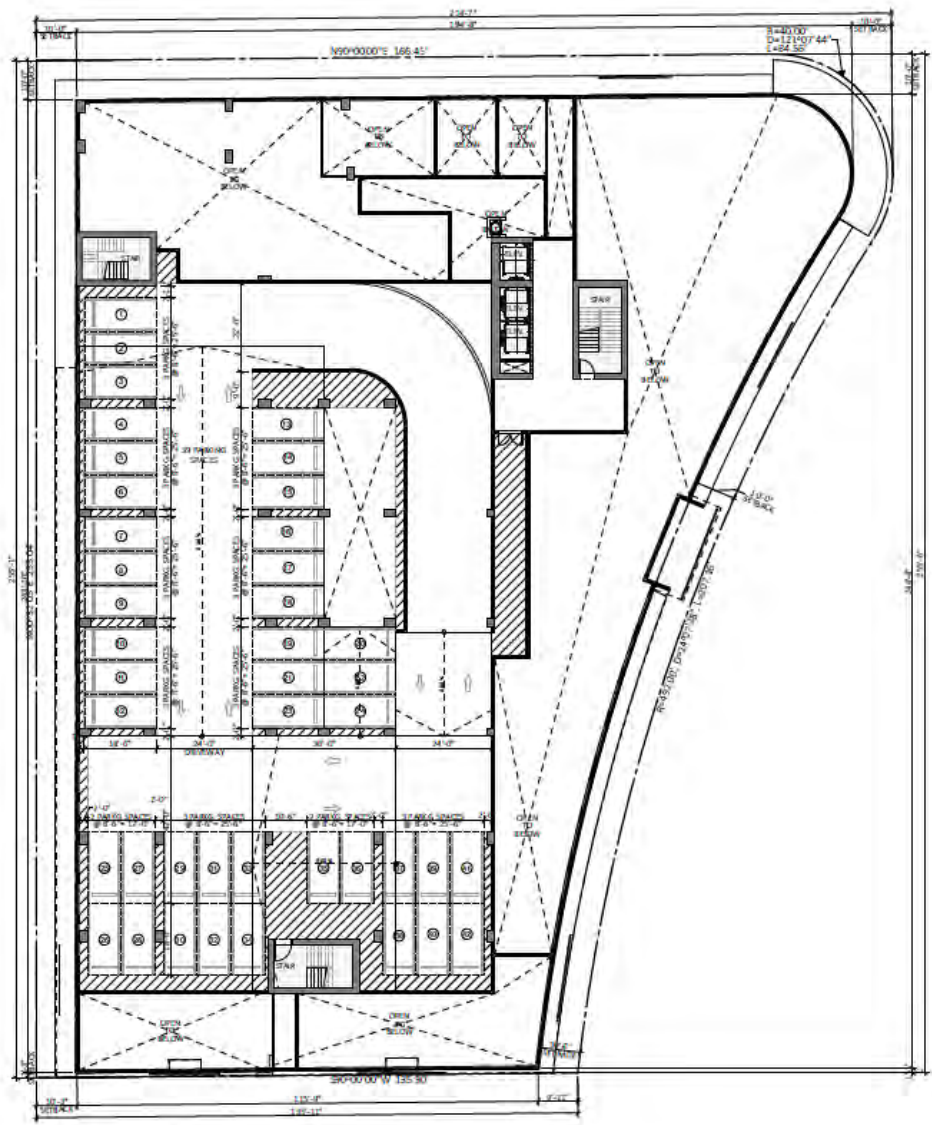
A SITE PLAN

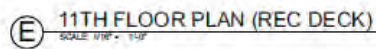


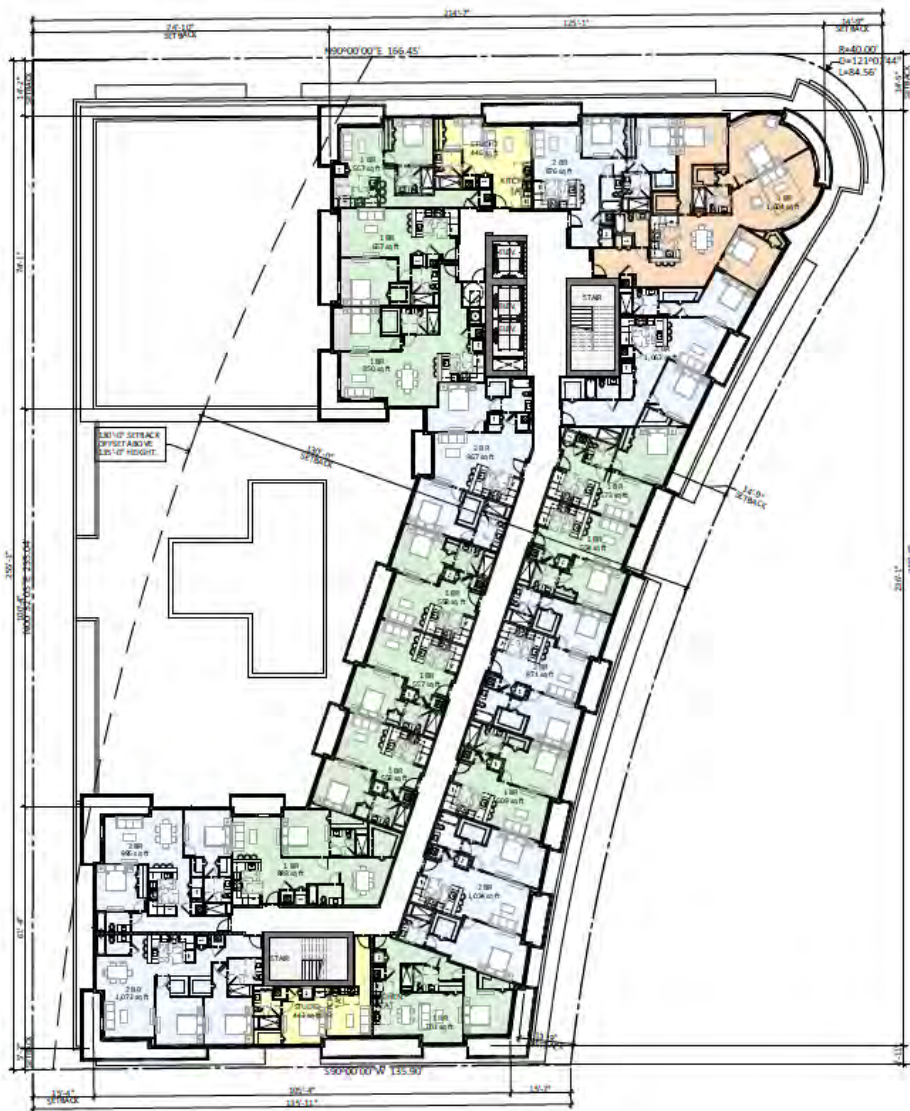
© TYPICAL GARAGE FLOOR PLAN (LEVELS 3-9)

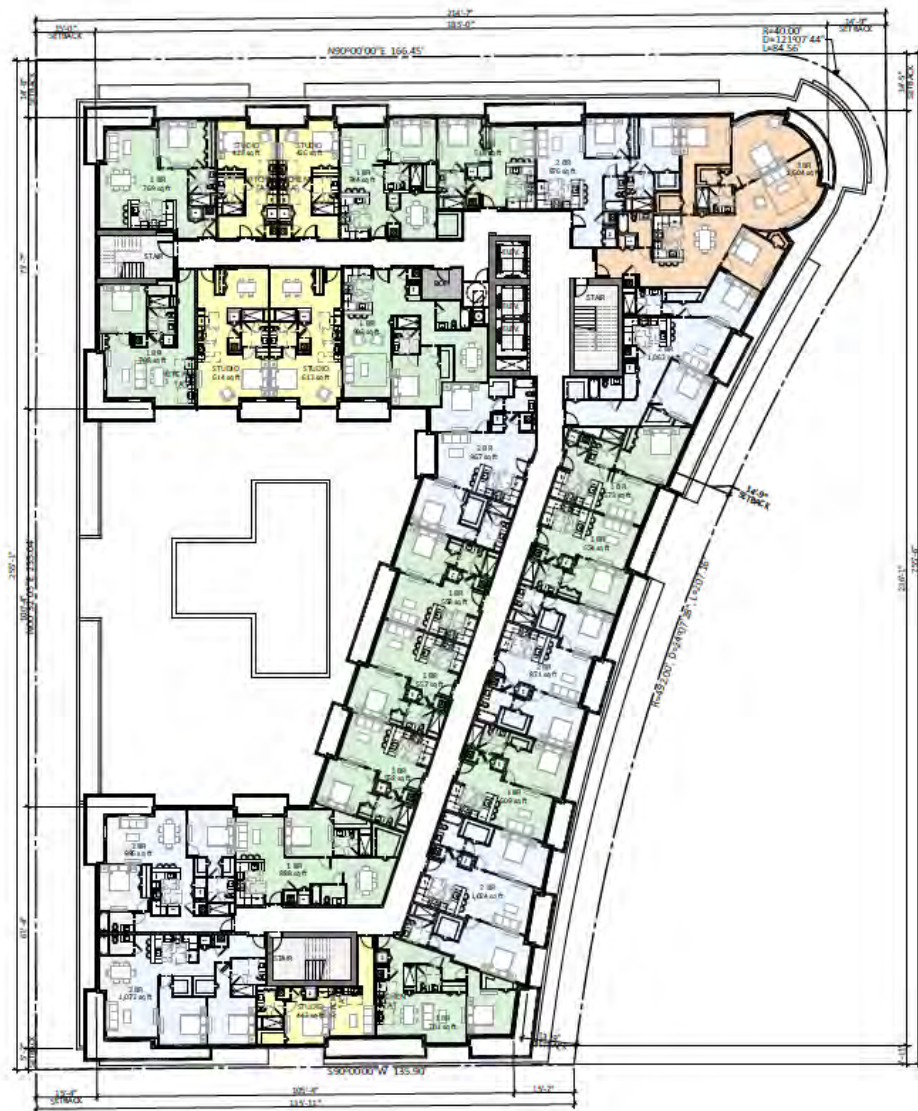
Ⓑ SECOND FLOOR PLAN

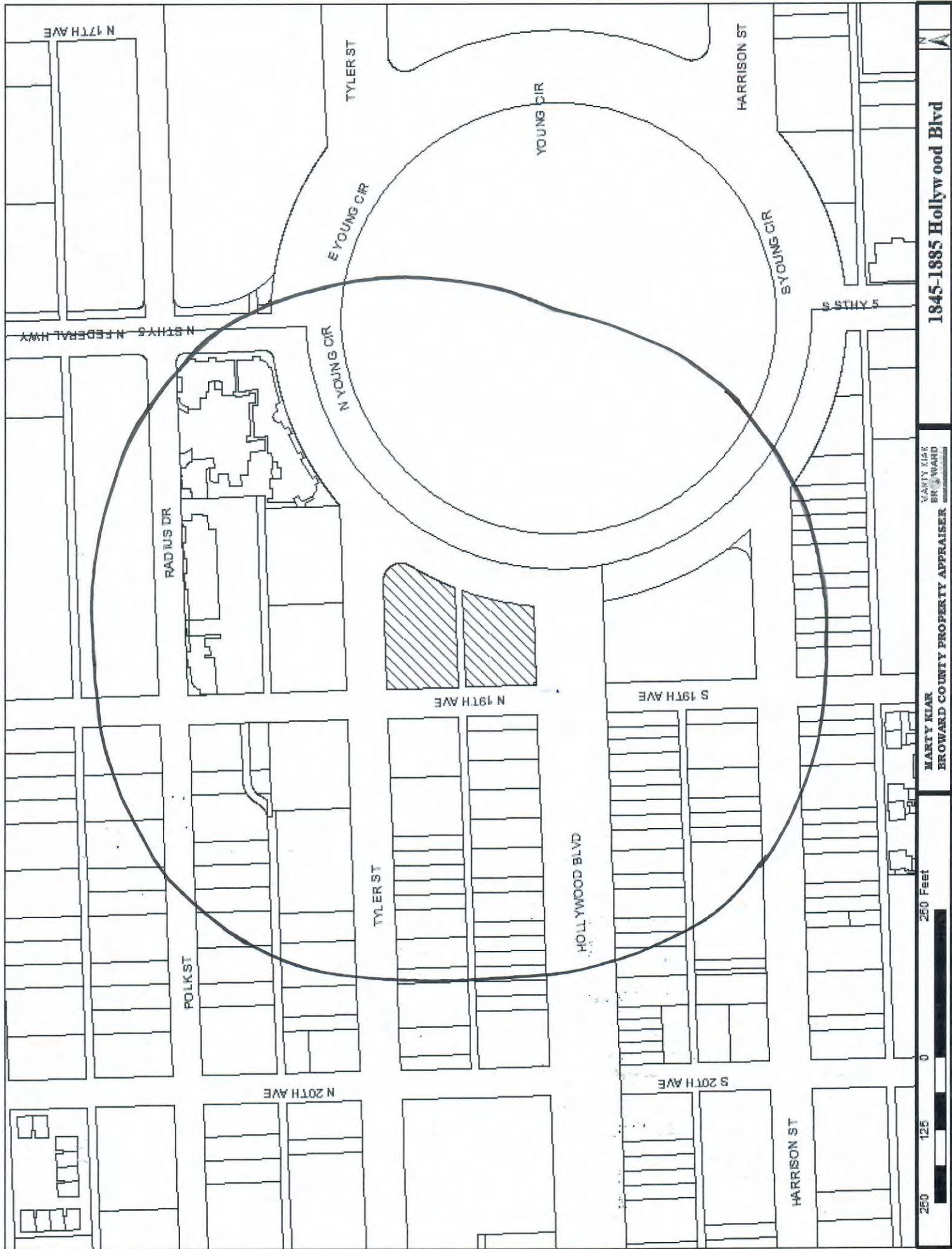
