A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, ESTABLISHING THE FEES FOR MOBILE FOOD DISPENSING PERMITS AND SPECIAL PARK MOBILE FOOD DISPENSING PERMITS FOR THE SALE OF FOOD FROM MOBILE FOOD DISPENSING VEHICLES SUCH AS FOOD TRUCKS AND FOOD CARTS IN ACCORDANCE WITH SECTION 122.02 OF THE CODE OF ORDINANCES.

WHEREAS, on June 4, 2014, the City Commission passed on first reading PO-2014-11 which amended Chapter 122 entitled Peddlers, Solicitors and Itinerant Merchants to revise the regulations for the sale of food from mobile food dispensing vehicles such as food trucks and food carts; and

WHEREAS, on June 4, 2014, the Director of Parks, Recreation and Cultural Arts made a presentation to the City Commission outlining the proposed permit fees for mobile food dispensing permits and special park mobile food dispensing permits; and

WHEREAS, on June 18, 2014, the City Commission passed and adopted on second reading PO-2014-11; and

WHEREAS, in accordance with PO-2014-11, the City Manager and Parks, Recreation and Cultural Arts Director and Director of Parking and Intergovernmental Relations recommend the following:

(A) Special Park Mobile Food Dispensing Permit Fees:

(1) Special Event Permit Holder (Main sponsor of the event pursuant to Chapter 102 of the Code of Ordinances): In addition to remitting the Special Event Application Fee as established by resolution of the City Commission, a Special Event Permit Holder shall pay the following permit fee:

- (a) \$ 100.00 per day for events that have a duration of one to three days
- (b) \$ 500.00 per day for recurring events that have a duration of more than three days.

(2) Special Park Mobile Food Dispensing Permit: An owner/operator of a Mobile Food Dispensing Vehicle providing services to a Special Event Permit Holder shall pay the following permit fee:

- (a) \$ 75.00 for a six (6) month permit
- (b) \$ 125.00 for a twelve (12) month permit
- (B) Mobile Food Dispensing Permit Fees:
  - (1) \$75.00 for a six (6) month permit.
  - (2) \$125.00 for a twelve (12) month permit.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:

<u>Section 1</u>: That the permit fees for the for the sale of food from mobile food dispensing vehicles as provided for in Section 122.02 of the Code of Ordinances are hereby established as follows:

(A) Special Park Mobile Food Dispensing Permit:

(1) Special Event Permit Holder (Main sponsor of the event pursuant to Chapter 102 of the Code of Ordinances): In addition to remitting the Special Event Application Fee as established by resolution of the City Commission, a Special Event Permit Holder shall pay the following permit fee:

- (a) \$ 100.00 per day for events that have a duration of one to three days
- (b) \$ 500.00 per day for recurring events that have a duration of more than three days.

(2) Special Park Mobile Food Dispensing Permit: An owner/operator of a Mobile Food Dispensing Vehicle providing services to a Special Event Permit Holder shall pay the following permit fee:

- (a) \$ 75.00 for a six (6) month permit
- (b) 125.00 for a twelve (12) month permit
- (B) Mobile Food Dispensing Permit
  - (1) \$75.00 for a six (6) month permit.
  - (2) \$125.00 for a twelve (12) month permit.

RESOLUTION TO ESTABLISH PERMIT FEES FOR MOBILE FOOD DISPENSING VEHICLES SUCH AS FOOD TRUCKS AND FOOD CARTS IN ACCORDANCE WITH SECTION 122.02 OF THE CODE OF ORDINANCES.

<u>Section 2</u>: That this resolution shall be in full force and effect immediately upon its passage and adoption.
